On Tuesday the 16th of May 2017 I was on duty in uniform engaged in mobile patrol, with PC 13930 OVENDEN as XB50. Approximately 1945hrs we attended Bridge House, Bridge Road, Sheerness in relation to a disturbance where screaming and shouting could be heard coming from one of the flats. When we arrived there were a number of residents outside the front door of the property and I could hear shouting from inside. Shortly after this a female I now know as [REDACTED] came out of the flat screaming and shouting and trying to get away from the property. She was very aggressive towards me and appeared very drunk. She stated she had been drinking in The Ivy Leaf pub and this was confirmed by her friends that were there at the time. Due to her trying to leave the area and me believing she had committed offences as mentioned on the initial call, I prevented her from leaving and had to physically restrain her when she became violent. Due to the nature of the call SECAS had arrived at the same time as us and were waiting to find out if they were required. After enquiries with the neighbours in the flats it was established they had called police as [REDACTED] was drunkenly punching doors within the flat but she had caused no damage and there were no substantive offences. Due to her aggressive and uncontrollable behaviour SECAS tried to assess her in case she had also taken drugs but she was lashing out and being violent towards them. She was detained by them using their powers under the Mental Capacity Act and was restrained using handcuffs and fastrap leg restraints whilst in the ambulance.

She was constantly trying to wriggle free from these restraints and kick the ambulance staff and at times both PC OVENDEN and I had to use our full body weight to hold her down. [REDACTED] was behaving like a wild animal and was swearing and screaming at us constantly. Due to her behaviour I believed she may also have taken drugs as well as alcohol. SECAS conveyed her to hospital to be medically assessed and due to her continuing aggressive behaviour, PC OVENDEN travelled in the ambulance and once in the hospital we were placed in the paediatrics ward. There were sick and injured children in this ward who were being supported by their caring families and despite being told numerous times to be quiet, [REDACTED] continued her swearing and screaming tirade which was upsetting other patients and their families on the ward. Staff found [REDACTED] a medical room within the ward which had a door that could be kept shut so as to try and isolate her from the other patients. She was still handcuffed and fastrapped to prevent her injuring someone and the Sister In Charge wanted to have her moved to an adult ward straight away as she did not feel her behaviour and foul language was suitable for a paediatric ward. [REDACTED] eventually calmed down sufficiently to be medically assessed and due to her wanting to discharge herself, PC OVENDEN and I drove her home to her mothers house to prevent her causing more issues around the hospital.

On TUESDAY 16th MAY 2017 I was on duty in full uniform in call sign XB50 with PC 13152 WYNN. Approximately 1930 hours a report came in of a disturbance at BRIDGE HOUSE in Sheerness and we were informed of a female screaming and shouting, who was possibly intoxicated and may have taken drugs, and may have caused some damage to the main door of the building. We arrived approximately 1945 hours round the back of the building and could hear some loud screaming. As we approached the front of the building we were presented with a young female. SECAS were also present. She was slurring her words, she could barely stand, and she smelt of intoxicating liquor. The female was clearly intoxicated. She was very distressed and difficult to control and was very abusive towards officers and the paramedics, repeatedly saying she was going to 'knock us out'. Due to her manner she was placed in handcuffs to the back and PC WYNN arrested her on suspicion of S.5 Public Order and Criminal Damage. The female became known to me as [REDACTED], also known as [REDACTED], date of birth [REDACTED], making her only sixteen years of age. PC WYNN and I were informed by a friend of Sylvie's who was at the scene that she had been drinking in excess all day at THE IVY LEAF public house, and had possibly taken cocaine. We were also informed that it was [REDACTED] late grandmother's birthday and she had been very close to her. Due to the possible medical issues displayed [REDACTED] was de-arrested by officers and was taken to the nearby ambulance and detained under The Mental Capacity Act by SECAS. [REDACTED] continued to shout abuse and threats

towards police officers and SECAS, as well as attempting to bite us and kick us. Eventually she was restrained on the bed in the ambulance by using the straps on the bed and fast straps provided by officers. The handcuffs were kept on and secured to the back due to the threats █████ continued to make. PC WYNN followed the ambulance in the police vehicle, and I remained in the ambulance with █████ and a member of SECAS. █████ displayed a mixture of emotions whilst in the ambulance, but her behaviour did suppress. She appeared to sleep but after a minute she would ask where she was going and for the handcuffs to be removed and struggle. She would then become very emotional and expressed her feelings to me regarding her late grandmother. She then made comments on the amount she had drunk and the drugs she had possibly taken, and somewhat appeared to boast about it. She continued this pattern of behaviour for the journey to the hospital. Approximately 2100 hours we arrived at Medway Hospital and █████ was taken into A&E Children's Ward. Her behaviour improved dramatically and she became civil with PC WYNN and I. The hospital conducted medical checks and resulted in no medical issues being found. As a result █████ wanted to discharge herself and was adamant she was going to walk home from Gillingham to Sittingbourne if no one was available to pick her up. Approximately 2300 hours PC WYNN and I conveyed the young female home and appeared in high spirits saying she felt like going out drinking. █████ informed us that she had taken cocaine and she had been drinking, but this was before attending THE IVY LEAF public house, where according to her refused to serve her.
