Introduction

- 1. Each year the Council reviews its appointments to outside bodies and trusts at the Annual Council meeting following discussion at the Executive. Tables A and B set out the current representation on trusts and outside bodies; Tables C and D set out where the Council has been advised that there are vacancies on school governing bodies.
- 2. Nominations were considered at the Executive Meeting on 13th May 2009 and the tables have been modified to include recommendations put forward at that meeting. <u>Any changes to representation from 2008/2009 are highlighted in bold.</u>
- 3. Those Councillors presently nominees on an outside body were requested to submit their annual report and this was produced as a booklet in April 2009.
- 4. In respect of the vacancies on school governing bodies, once nominations have been received Democratic Services will provide contact details for the school to that councillor; that councillor may be required to submit an application in support of their nomination.

Terms of appointment for Bensted's Charity
