## 1 Purpose of Report and Executive Summary

1.1 Under Section 11 of the Local Government Act 2000, the Executive comprises the Leader and at least two and not more than nine Members (ten members in total) [Section 11(8)]. The Mayor, Deputy Mayor and members of Overview and Scrutiny Committees may not be members of the Cabinet [Sections 11 (7) and 21 (9)m respectively].
1.2 Under the Executive arrangements agreed in the Constitution, the Council appoints the Executive Members from their number. The Leader: -

- appoints a Deputy Leader,
- allocates the Executive Members' portfolios and;
- delegates any executive powers or functions to executive members, committees of the executive or officers.
The Leader must then notify all Members of the Authority of their decision.
1.3 The Leader proposes an Executive as set out in Appendix I together with an outline of portfolio responsibilities as set out in Appendix II (to be tabled).
