Purpose of Report and Executive Summary

1.1 This report requests the Council to formally establish the Committees for the municipal year 2011/12 and to agree their terms of reference.

2 Background

- 2.1 The Council must establish:
 - (a) At least one Overview and Scrutiny Committee
 - (b) The Standards Committee
 - (c) A Committee under the Licensing Act 2003

The Council may also establish other Committees

- 2.2 As part of the review of the Constitution carried out during the last municipal year, a number of changes were made to the committees of the Council and to their terms of reference. These have resulted in amendments to Part 3.2.2 of Swale Borough Council's Constitution:
 - Audit Committee
 - Emergency Committee
 - General Licensing Committee (including Hackney Carriage and Private Hire Vehicle functions)
 - General Purposes Committee (including the Appointments Sub-Committee)
 - Licensing Act 2003 Committee
 - Planning Committee
 - Policy Overview Committee

- Scrutiny Committee
- Standards Committee

3 Proposal

- 3.1 That the Committees that the Council has concluded it requires to discharge functions for should be established and that the terms of reference, as amended, for those Committees should be agreed.
- 3.2 There have been some amendments to the terms of reference of the General Purposes, Policy Overview, Scrutiny Committees, which have been agreed or are consequential from decisions taken at Council on 21 July 2010, 15 September 2010, 13 October 2010, 12 January 2011 and 23 February 2011.

4 Alternative Options

4.1 Any changes to the number of Committees, or their terms of reference, must be included in the Constitution and as such will require approval of the Council. Any proposal to establish or discontinue a Committee that is currently included within the Constitution, would affect the calculation of the allocation of seats on Committees and would require approval of the Council.

5 Consultation Undertaken or Proposed

5.1 The revised Committee structure has largely been as a result of the review of the Constitution and takes into account legal requirements and best practice. All Members have been consulted and informed through their involvement at General Purposes Committee, full Council or both.
