Purpose of outside body:

The purpose of the Joint Advisory Committee (JAC) is to provide advice to those of its members with statutory responsibilities for the effective management of the Kent Downs Area of Outstanding Natural Beauty.

What you contributed:

- 1. Support for the Woodland pathfinder project local business/land owner in Swale has actively contributed to this project. I asked that a leaflet be published to help householders considering wood fuel systems to give some guidance on this technology and how it can support the local coppice woodlands.
- Requested that AONB push gov't to prevent the compartmentalisation and sub-division of ancient woodland and create
 buffer zones around it with a cohesive management of woods in their entirety. NFU raised issue of plotting and
 supported my comments. I pointed out the mismatch of permitted development and National Plannning Policy where
 ancient woodland falls outside the AONB.
- 3. Requested AONB feed into Swale's current LDF consultation that closes in May
- 4. Support for the sustainable tourism agenda including the Our Land (www.our-land.co.uk/holidays/the-kent-downs) and asked local business owner in Swale what the she thought helped attract visitors to the area.
- 5. Requested AONB provide advice on buffer zones to the AONB including good practice for managing these areas. AONB in Swale is defined by an artificial boundary along the M2. Clearly areas north of M2 in Swale have the qualities of AONB and should either be considered for inclusion or at the very least managed to maintain the setting of AONB.

What you learnt:

- Swale has considerable gains to be made from the woodland pathfinder project not just in land management but
 economically. If promoted and supported in Swale this could unlock employment opportunities for businesses not just
 supplying wood fuel but also installing the technology and advice.
 RECOMMENDATION: Swale Exec and senior management explore ways to unlock the potential of the pathfinder
 project in Swale.
- 2. Swale has a number of ancient woodlands some fall outside the AONB and therefore do not have the benefit of AONB planning status and prohibition of permitted development rights. Swale to assess and implement how it can protect ancient woodland from compartmentalisation and sub-division of ancient woodland and create buffer zones around it with a cohesive management of woods in their entirety. In particular how to stop inappropriate fencing and development (permitted or otherwise) in and adjacent to the boundary of ancient woodland.
 RECOMMENDATION: Exec and senior officers consider how to implement protection of ancient woodland including the appropriate use of Article 4 orders removing permitted development.
- AONB will comment and provide advice to local authorities on planning applications and Core Strategy consultations as appropriate.
 RECOMMENDATION: Officers actively engage with AONB and consider "Setting"/buffer areas that boarder the AONB in Swale.
- It was interesting to find that sustainable tourism was a major contributor to the economic success of rural economy across the AONB, it seems to me Swale and the Swale area of the AONB could be far more active in this area and is lagging behind other areas. The sustainable tourism agenda could significantly add to Swale's (rural) economy not just in the AONB but across the borough. The business owner we visited commented how the Faversham Food Trails had proved very popular to visitors/walkers (www.faversham.org/visit_faversham/walking/Kents_Best_Food_Trails.aspx), however there were no longer any paper copies available for visitors as funding for this had run out under the FEP. It would be worth looking into further funding for print these. It was fascinating to see how implementing sustainable practices had created viable rural business and had improved the local environment. The range of visitors was immense and their reasons for visiting broad from medieval reactment groups to ramblers to overnight stopovers for the Channel crossing etc. Clearly preset walks extolling the virtues of Swale with detailed local information/guides have had a positive affect on tourism. It occurs to me that Swale could significantly up its game by creating more of trails these across the borough, in the villages around Sittingbourne, and on Sheppey. It seems we are missing cycling routes with maps akin to the Food Trails that stretch out across the AONB and along the No.1 cycle route and on the isle of Sheppey. RECOMMENDATION: Swale Exec and Senior Officers to actively pursue the rural sustainable tourism agenda and look to capitalise on Our Land website and increase the number of guided walks and cycle routes across the borough and specifically in the AONB and adjacent areas to capitalise on the boroughs natural assets. It should consider teaming up with neighbouring boroughs to create a network straddling the borough linking areas.
- 5. Planning policy still appears to be rather fuzzy. AONB's and the areas adjacent to them are not a comprehensively covered in terms of policy and much of the detail is left to local authorities to determine **RECOMMENDATION**: Exec and Senior Officers ensure the LDF is comprehensive in its approach and policy wording to the AONB and the areas adjacent to it including areas those that make up the AONB "setting".

Kent Downs AONB Joint Advisory Committee Summary Activity Report 2011-2012.

Provided to Local Authority Members of the Kent Downs AONB Joint Advisory Committee to assist in reporting on the activities of outside bodies.

Statutory management planning

The Statutory Kent Downs AONB management plan, adopted by all Local Authorities with the AONB in their jurisdiction, is what drives all of the work of the AONB partnership, its detailed action plan has been overseen by the Kent Downs AONB Joint Advisory Committee.

The Joint Advisory Committee has met twice during the year with agendas covering AONB Unit project activity in support of the management plan action plan, monitoring delivery and highlighting successes. The JAC has also considered current issues for the AONB such as AONB Boundary review, budget and activities, governance and planning matters.

Partnership projects

Valley of Visions Landscape Partnership Scheme

This year was initially planned to be the final year of this £2.4m principally Heritage Lottery Funded project operating in the Medway Valley. Through careful financial management we have been working to secure an extra year of activity, this will be focused on additional project activity and securing the legacy of the project.

Key activity delivery this year include;

Chalk grassland conservation

- Restoration work completed at Ladd's Farm. Ongoing active management regime initiated on all 27.5 ha with two Hebridean sheep flocks. A further 1.5 ha cleared in early 2012 and will be included in management regime.
- All work at five other sites (Burham to Wouldham Downs Birling Escarpment, The Brockles, Nashenden Down and Culand Pits) all completed and now in active management. Results in a total of over 140 ha of chalk grassland now in positive, long-term management.

Wetland conservation

 All programmed works completed on four marshland sites: Holborough Marsh, Burham Marsh, Halling Marsh and Wouldham Marsh. All sites, totalling 177 ha in long-term positive management. Restoration management completed at Aylesford Old Pit wet woodland site (5 ha) and long term management put in place.

Heritage hedgerows

• 4.5km of hedgerow planted or managed within the Medway Gap

Access

- Fully subscribed national Securing the Landscape (STL) conference held in July 2011, sharing VoV's approach to solving illegal motorised access and environmental crime issues.
- Continuing effective strategic STL approach headed by Kent Police.
- Funded PCSO role embedded with VoV team supporting physical works with enforcement and community liaison.
- Completed project planning study for Aylesford to Allington Lock shared use path

 will unlock the aspiration for shared use path between Maidstone and

 Rochester.
- 1km of shared use path completed at Ranscombe Farm
- 800m of new permissive footpath at Holborough Marsh.
- · Reprints of VoV's seven community trail leaflets due to popular demand

Events

- 30 events organised and run by VoV with approximately 450 attendees.
- A further 139 events run by partner organisations promoted through VoV

Heritage conservation

- Restoration of Bishop's Palace scheduled monument in Halling complete. Landscaping of site close to completion.
- LiDAR survey of Medway Gap undertaken to provide information on heritage features hidden by vegetation and to support monitoring of vegetation encroachment on open habitats such as chalk grassland.

Community

- Neighbourhood planning projects completed in Halling and Wouldham Primary Schools culminating in presentations made to local dignitaries and community partners.
- Medway Mosaics community archaeology project established with local volunteers recruited to 'ground-truth' LiDAR results in the Birling and Burham areas of the valley.
- River Wardens scheme co-ordinated by Medway Valley Countryside Partnership now self-sustaining.
- Support of Parish Council led volunteer group to undertake biodiversity and heritage conservation at the White Pit quarry near Halling.

White Cliffs Landscape Partnership Scheme

The Kent Downs AONB Unit led the submission of the successful stage 1 application for this £2.4m scheme which will focus on landscape conservation and enhancement in the Dover and Folkestone area of the AONB, and its surroundings. Again this scheme is funded principally by the Heritage Lottery Fund. This year the project lead was taken up by Dover District Council but the AONB Unit provides detailed support and Chairmanship

to the Partnership Board, a stage 2 (final) submission has been completed on time and within the agreed budget.

Landscape and Nature for All projects.

The Kent Downs AONB has provided a lead for 14 UK partners in this 4.4m Euro project which has been operating over 4 years, this year being the final year of delivery and closedown. This project has focused on the delivery of the biodiversity activity promoted through the Kent Downs AONB management plan. Outputs include;

- 23 Parish Councils involved
- 370 ha of chalk grassland conserved
- 1450 ha woodland under environmental management, covering 43 sites
- New website with woodland management advice for private landowners
- 4 new leaflets on woodland management for private landowners
- 44 events for children, families and volunteers
- 8 information panels
- 290 adult volunteers involved through awareness raising event and practical tasks
- 1575 children involved through woodland discovery and tree plating events
- 3 ha of new woodland planted
- 122 ha of wetland managed
- 70 volunteers involved in pond creation and monitoring as well as marshland monitoring
- 25 bat sites surveyed
- Action plan for adder protection and a leaflet on adder habitat conservation and management
- 110 events for various community groups
- 32 landscape enhancement projects completed, most of them in publicly accessible sites improving visitor experience; further 40 local projects delivered with community groups

The Kent Downs AONB wood fuel pathfinder project

The management of woodlands in the Kent Downs AONB has been identified as a key priority, the AONB being one of the most wooded landscapes in England. This year we have secured and established the national wood fuel pathfinder project with the support of the Forestry Commission and supported by Interreg funding, this project has been very active supporting over 80 sites, providing support for woodland owners and encouraging the potential for wood fuel demand from a number of sites including 25 schools.

Sustainable Rural Tourism in the Kent Downs - Our Land project

This year saw the ministerial launch of a sustainable rural tourism project for the Protected Landscapes (National Parks and AONBs) of the south east of England. The Kent Downs AONB has provided a lead role in securing the £1m RDPE grant which supports this ground breaking public private partnership. Since the October launch 32 Kent Downs tourism businesses have signed up to 'Our Land', with 11 more in progress and an active recruitment programme. The Our Land project is all about getting tourism right in the Kent Downs AONB, so that is supports local business and services, provides a great experience for visitors and benefits the landscape. please visit http://www.our-land.co.uk/holidays/the-kent-downs for more information.

The Kent Downs AONB Landscape Education Project

This exciting project has focused on getting school children into the AONB – this has been described by at least one participant as 'the best school trip ever'. This year amongst many other things we launched a new website http://education.kentdowns.org.uk/ additionally we held 12 walks which includes one with was for teachers, 324 children have participated in the walks together with 60 teachers, of which 53 have undergone training, 187 of the children came from rural areas and 117 form urban areas.

Undergrounding of overhead cables

Work has finally started on the Undergrounding scheme on the Woodland Trusts Hucking Estate, in the Mid Kent Downs; Approx. 2km of 11kV cabling is now being removed at a total cost of £352,000

Final approval for the scheme at Ranscombe Farm in Medway has been secured. 1.3km of 11kV to be removed adjacent to the North Downs Way. An estimated cost of £162,000.

Works to the scheme at Saltwood Castle are going through the final stages with UK Power Networks working on the landowner way leave agreements. Work on this scheme to start later in the year. Approx. 900m of 11kV to be removed.

AONB Partnership activity in support of AONB management plan policies

Positive Planning function

We seek to provide an active and supportive planning function to the Local Authorities, partner organisations and communities of the Kent Downs. The Kent Downs AONB is probably the most pressurised AONB from a planning point of view and we seek to be positive and professional in providing helpful planning advice from the Kent Downs AONB perspective and drawing from the management plan.

Our primary focus is to support Local Authorities in the preparation of the policy framework through development plans – we do this by engaging in the early stages of plan making and through active and thorough engagement in the consultation process, although we have also provided comment on over 40 individual applications, usually at the request of JAC members or Local Authority officers.

Overall this year we received 100 general planning requests and responded to 41 of them. In addition we have been involved in providing pre-application advice in two major development cases, responses to the Minerals and Waste Development Framework, 7 Core Strategies, 6 Wind turbine applications, 2 quarry applications and 4 pipelines. In addition we worked at the regional and national level in support of SE Protected Landscapes Planners Meetings and the National Association of AONBs response to the Draft National Planning Policy Framework.

Guidance documents

The AONB design guidance documents have been consistently well received by Local Authorities, developers, land managers and farmers along with many others who

influence land in the AONB. This year we have worked to update both the Kent Downs Land Manager's pack, the landscape design handbook and we have been actively promoting the more recent Rural Streets and Lanes Design Handbook. We have finalised a new design guidance document in partnership with English Heritage, KCC Heritage and the Kent Design Initiative, focusing on the design of farmsteads in the landscape. The advent of the National Planning Policy Framework, with a focus on 'good design' is likely to make our design guidance more important in the future.

Farming

The Kent Downs is a farmed landscape and promoting and supporting sustainable farming which supports the landscape is a key issue. This year we have taken a new step in recognising best practice through the sponsorship of the Kent Food, Farming and Landscape Award as part of the Taste of Kent Awards, this new award received significant publicity and there were 12 excellent entries – it has been seen as a real success in providing much needed recognition for the good work which has been achieved. We have also worked on the revision of the Kent Downs AONB farm diversification tool kit.

Communications

The Kent Downs AONB web site

This year has seen extensive work updating the web site, the new site is due to go live early in 2012, and will be linked to social media, have a more intuitive layout and updated content. The existing site continues to be very well used with over 1m visits to our most popular pages and 224,000 downloads.

The Kent Downs Orchid newspaper

Two editions of the Kent Downs AONB newspaper have been published a total of 140000 papers

The newspaper provides news and updates to Kent Downs AONB communities and those who live in and around, it has a web presence on the Kent on Sunday website along with the Kent Downs AONB site and provides an important resource in support of tourism in the AONB.

Gateway signs

Already over 80 village gateway signs, signalling that the village is in the Kent Downs AONB have been installed, this year we have secured more funding and another 25 are in line for being installed.

- 3. Supported efforts to stabilise the charity's income flow; given its vulnerability to weather (affecting the income from the outdoor pools)
- 4. To the discussion on how to resolve the difficulties arising from the complex legal ownership structure of the pools and environs
- 5. To discussions regarding specifics areas such as smoking areas and the children's playpen on the poolside.

What you learnt:

- Faversham Pools has fantastic facilities the outside pools and rapids are unique to Swale and the only outdoor pool with 1/3/5m diving board in UK – this should be broadcast from the roof tops! http://www.favershampools.com/page3.html
- 2. The charity has historically had a chequered relationship with Swale however this has improved over the course of the last year.
- 3. Facilities are well managed and maintained on a very tight budget.
- 4. Funding opportunities to be exploited for capital investment and maintenance
- 5. Faversham Pools provide very good facilities at minimal cost to the public/Council purse when compared to other leisure facilities in the borough; Swallows and Sheppey.
- 6. Faversham Pools users have to pay for car parking where as the council tax payer subsidises users of Swallows and Sheppey Complexes (via a parking refund).

Purpose of outside body: Represent the Authority on the LGA which meets in full plenary session, twice annually – once in March and once during the conference session.
What you contributed: I am the Swale Borough Council appointee to the Rural Commission having completed a term of office as Chair to the Rural Commission in 2011. I stood for and was elected to the LGA Rural Commission Policy Review Group. I was made Conservative Party appointee (Vice-Chairman) to the LGA Audit and Scrutiny Panel. I am currently part of a sub-group to review the LGA offer to member authorities. I am an appointed member to the LGA's monthly Councillor Forum and attend when possible.
What you learnt: Invaluable networking opportunities with most Council Leaders across all tiers of Local Government. Good insight into, and hopefully ability to influence, emerging Government policy.
