Recommendation	The Council is asked to agree the political balance calculation as set out in Appendix I.
	2. The Council is asked to agree to establish the Committees set out in Appendix II, with the terms of reference as set out in Appendix III, for the 2013/14 Municipal Year.
	3. The Council is asked to allocate seats to those Committees and to agree the appointment of Members to those Committees, in accordance with the wishes of Group Leaders, as set out in Appendix IV (to be tabled at Council).
	4. The Council is asked to agree the Chairman and Vice-Chairman of those Committees, as set out in Appendix V (to be tabled at Council).
	5. That Mrs Christine White (Swale Council for Voluntary Service) and Mr Paul Murray (Isle of Sheppey Academy) be appointed as non-voting co-optees onto the Policy Overview Committee for 2013/14.

# 1 Purpose of Report and Executive Summary

1.1 Section 15 of the Local Government and Housing Act 1989 requires Local Authorities to review the allocation of seats on committees at the annual meeting, or as soon as possible after it (set out in Appendix I). Once the Council has agreed the allocation of Committee places between the political groups the Council must then appoint the nominees of the political groups to the committees.

## 2 Background

2.1 Political groups on the Council are formed in accordance with the Local Government (Committees and Political Groups) Regulations 1990 when 2 or more Councillors must notify the Proper Officer of their wish to be treated as a group.

The following principles apply to the allocation of seats:

- (a) That not all seats on the body to which appointments are being made are allocated to the same political group;
- (b) That the majority of seats on each Committee is allocated to a particular group if the number of persons belonging to that group is a majority of the authority's membership;
- (c) Subject to (a) and (b), that, when allocating seats to a political group, the total number of their seats across all the ordinary committees of the Council, must reflect their proportion of the authority's membership; and (d) Subject to (a) and (c), that the number of seats on each committee is as far as possible in proportion to the group's membership of the authority.

Sub-committees are also governed by the political balance rules, but it is not necessary to add up all the sub-committee seats and then allocate them in proportion. As far as this is predictable, the allocation of seats on each sub-committee should reflect the proportional representation of the political groups on the Council.

- 2.3 Each of the political groups are entitled to a certain number of seats on committees. This is based on their percentage representation on the Council as a whole, as detailed in Appendix I. This is then required to be manually adjusted to ensure that the number of seats allocated to a particular group matches and does not exceed their entitlement.
- 2.4 To ensure overall political balance the Conservative Group need to gift one seat to the Independent Group, which the Leader has advised will be on Policy Overview Committee, and the Labour Group need to gift two seats to the Ungrouped Member, which the Leader of the Labour Group has advised will be on Audit Committee and Policy Overview Committee.
- 2.5 The Council must establish:
  - (a) At least one Overview and Scrutiny Committee
  - (b) A Committee under the Licensing Act 2003 The Council may also establish other Committees
- 2.6 Appendix II sets out the terms of reference of Committees as currently agreed by the Council.
- 2.7 The Policy Overview Committee wish to appoint Mrs Christine White, representing Swale Council for Voluntary Service, and Mr Paul Murray,

representing the Isle of Sheppey Academy to the Panel as non-voting co-optees to assist with scrutiny reviews during the 2013/14 civic year. The recommendation was made at the Policy Overview Committee meeting on 21 March 2013 and, in accordance with Overview and Scrutiny Procedure Rule 4, Council are asked to approve the appointments.

### 3 Proposal

3.1 The Council is asked to agree the recommendations set out on page one of this report.

## 4 Alternative Options

4.1 Council can decide to change the number and size of Committees, however, this will have an impact on the number of seats available on the Council and will therefore require the political balance to be re-calculated to reflect this. Members are encouraged to make Officers aware in advance of the meeting of any proposals of this nature. Any changes to the terms of reference of Committees also need to be approved by Council.

## 5 Consultation Undertaken or Proposed

5.1 All Group Leaders have been made aware of this report and have been asked to advise Democratic Services of their nominations to seats on Committees for their respective Groups. This will be circulated at the Council meeting.

Such arrangements to include provision for the appointment by the authority of at least one independent person and to cover parish councils.  7. To consider applications for the grant of dispensations in accordance with the provisions contained within S.33 (b) (c) and (d) of the Localism Act 2011.  8. To set the allowances and expenses for the Independent Person and any Reserve Independent Person and any Reserve Independent Persons.  Three Members to be drawn from the Standards Committee  1. To consider any matter referred for investigation in accordance with the Council's agreed arrangements under Term of Reference 5 of the Standards Committee.  2. To conduct a hearing and take decisions in respect of a Member who is found on hearing to have failed to comply with the Code of Conduct, such actions to include:  • reporting its findings to Council for to the Parish Council for information;  • recommending to the Member's Group Leader (or

that he/she be removed from any or all Committees or Sub-Committees of the Council: recommending to the Leader of the Council that the Member be removed from the Cabinet, or removed from particular Portfolio responsibilities; instructing the Monitoring Officer to [or recommend that the Parish Council] arrange training for the Member; removing [or recommend to the Parish Council that the Member be removed] from all outside appointments to which he/she has been appointed or nominated by the authority for by the Parish Council]; withdrawing [or recommend to the Parish Council that it withdraws] facilities provided to the Member by the Council, such as a computer, website and/or email and Internet access; excluding [or recommend that the Parish Council exclude] the Member from the Council's offices or other premises, with the exception of meeting rooms as necessary for attending Council, Committee and Sub-Committee meetings.
