Recommendations	That the General Purposes Committee considers the feedback to the consultation.
	2. That the General Purposes Committee recommends to Council that the existing polling districts be retained, as set out in Appendix III.
	3. That the General Purposes Committee considers whether to recommend to Council that the polling places for the following wards are extended to allow more flexibility for the Returning Officer when designating the polling station. The Committee may wish to make comments regarding the alternative venues proposed and existing arrangements in place (details are in Appendix I):
	(a) Queenborough and Halfway;
	(b) St. Anns; and
	(c) St. Michaels.
	4. That the General Purposes Committee recommends to Council that it notes the (Acting) Returning Officers' representations as set out in Appendix II.
	5. That the General Purposes Committee considers whether to recommend to Council that the polling place for the SWS polling district (Sheerness West Ward) is extended to cover the whole polling district so that alternative venues can be explored. (Details are in Appendix II).
	6. That subject to (3) and (5) above, the General Purposes Committee recommends to Council that all other polling places be retained.

#### **Purpose of Report and Executive Summary**

- 1.1 The Council is required to undertake a review of polling districts and places by the end of 2011. The purpose of the review is to ensure that all electors in the Borough have reasonable facilities for voting and that, as far as is reasonable and practicable, facilities for voting are accessible for disabled people.
- 1.2 This report sets out the results from the consultation regarding the current arrangements, and asks the General Purposes Committee to consider those responses and make recommendations to Council regarding polling districts and polling places.

## 2 Background

- 2.1 The Electoral Administration Act 2006 introduced a requirement for Councils to undertake a review of polling districts and places in 2007 and every four years thereafter. In practice, however, we do monitor this more regularly and have when necessary made arrangements for alternative polling places/stations with the agreement of the Council/(Acting) Returning Officer. For example, for the elections in May 2011 the Council made changes to two polling places (Preston Church Schoolrooms and Seashells) so that the Returning Officer could designate those places as polling stations.
- 2.2 It may be useful to clarify that the Council is responsible for setting the polling district (a geographical area of a ward) and polling places (a geographical area within a polling district that the polling station must be located within). The (Acting) Returning Officer is responsible for locating the polling station which must be within the polling place.
- 2.3 On 29 July 2011 the Council published notice of the review which this particularly welcomed representations from any elector and from any person or body with expertise in access for persons with any type of disability. The notice was published on the website and at each of the district offices, and all councillors, county councillors, parish clerks, and MPs were made aware of the review, as were recent election agents and the Swale Community Empowerment network. A press release was also issued.
- 2.4 As part of the review of polling places/stations, consideration has been given to the guidance provided by the Electoral Commission in terms of the maximum number of voters that can be allocated to a polling station. More details about this are contained at the end of Appendix I.

- 2.5 Now that the Council has moved to whole Council elections, there are no planned elections scheduled for May 2012. However, there will be elections for Police Commissioners taking place on 15 November 2012, which the Returning Officer and his elections team will be responsible for organising for the Swale Borough Council area. It is likely that the annual canvass for 2012 will take place earlier than usual to avoid the election taking place within the canvass period. Further guidance is awaited regarding this. There may also, of course, be one or more by-elections.
- 2.6 Members will also be aware that there is the Local Government Boundary Commission is undertaking a Further Electoral Review of Swale Borough Council. Once the outcome of that review is known, there will a further formal review of polling districts and places to take account of any changes to ward boundaries.

#### 3 Proposal

- 3.1 There has been one representation (see Appendix I) to make a minor alteration to the WOS and WOT polling districts (in the Woodstock ward). However, given that there will be a further review after the outcome of the Further Electoral Review is known and we have not received any representations from members of the public, it is proposed to maintain existing arrangements for polling districts at this time.
- 3.2 In respect of polling places, you will see in Appendix I that we have received some representations to increase the number of polling places in some areas, or to change some of the polling places. In respect of suggestions to increase polling places in Grove, Kemsley and Milton Regis wards, we have reviewed the size of the electorate for those polling districts and do not consider that any changes should be made to the existing arrangements at this time, as outlined in Appendix I. This will of course be kept under review.
- 3.3 With regard to suggestions for alternative polling places in Queenborough and Halfway, St. Anns and St. Michaels, it is suggested that for the time being, the polling places for those particular polling districts are extended to cover the whole ward. This would allow officers time to explore the alternative options suggested once work on the annual canvass is completed, and would give the Returning Officer flexibility to designate the polling station within a larger polling place. In the meantime, Members may wish to make comments regarding the alternative polling stations suggested and the current venues.
- 3.4 Appendix II sets out representations made by the (Acting) Returning Officer for Sittingbourne and Sheppey. Members may wish to consider whether there are any suitable alternative venues to the West Minster Primary School (SWS polling district Sheerness West ward). At the time of writing this report, no feedback has been received from the ward members.

### 4 Alternative Options

- 4.1 The General Purposes Committee may make alternative recommendations such as to change the polling districts and/or polling places proposed. However, the proposals do meet the aim of the review (i.e. to provide reasonable facilities for voting) and also are within the Electoral Commission guidance regarding the number of voters at polling stations. Members are therefore encouraged not to make any polling district changes at this time, given that this will have implications for the revised version of the Electoral Register which will be published on 1 December 2011. Furthermore, as there will be a further formal review once the outcome of the Further Electoral Review is known, changing polling districts now is likely to cause confusion caused to the electorate.
- 4.2 If the General Purposes Committee is not minded to recommend that the Council extends the polling places for certain wards/polling districts, then Members may wish to continue with the existing arrangements for polling places at this time. This could be kept under review and a further report made to the General Purposes Committee/Council at a later date.

#### 5 Consultation Undertaken or Proposed

- 5.1 Details of the consultation process are set out in paragraph 2.3. Responses received are contained in Appendix I. The (Acting) Returning Officer for Sittingbourne and Sheppey also made observations and these are attached at Appendix II. The (Acting) Returning Officer for Faversham and Mid Kent has confirmed that he is happy with existing arrangements.
- 5.2 All ward members have been consulted regarding the comments received and initial response and at the time of writing this report no feedback has been received from ward members.

## 6 Implications

# Extract from the Guidance issued by the Chair of the Electoral Commission (in capacity as Chief Counting Officer for the Referendum that took place on 5 May 2011)

In those parts of the voting area where there are (local) elections:

- A polling station must not have more than 2,500 electors allocated to it
- In addition to a Presiding Officer, there must be one Poll Clerk for polling stations with up to 750 electors.
- One additional Poll Clerk must be appointed for polling stations with up to 1,500 electors.
- One further Poll Clerk must be appointed for polling stations with up to the maximum of 2,500 electors.

In those parts of the voting area where there are no elections (i.e. just the referendum):

- A polling station must not have more than 2,500 electors allocated to it.
- In addition to a Presiding Officer, there must be one Poll Clerk for polling stations with up to 1,000 electors.
- One additional Poll Clerk must be appointed for polling stations with up to 1,750 electors.
- One further Poll Clerk must be appointed for polling stations with up to the maximum of 2,500 electors.

At the elections held on 5 May 2011, I took the opportunity to assess the suitability of the polling stations that were in use during the day. The majority of stations were found to be suitable for their purpose; however, there are a few stations where I have made a few observations for the review.
