Background

Kent Police (Swale Area) have applied for a review of the premises licence of The Crown Hotel, High Street. Sheerness.

The reasons for the request are detailed in the attached review application. In this application the Police have outlined the recent history of the premises and the findings of their recent visits which are mainly crime related in respect of the handling of stolen goods, drug offences and the absence of a permanent DPS.

This premises currently holds a full Premises Licence, which was issued by Swale Borough Council in July 2005, the application was not referred to committee as there were no objections. Since 2005 the licence has been varied four times. There has never been the need for a hearing although the police have raised issues and conditions have been applied.

The premises licence is registered to Mr Steven Norton, he formally took over the licence in December 2007. Since this date five different DPS variations have been applied for. The current DPS Jason Ward was named on the licence in October 2010. He holds a personal licence issued by this Authority. Janet Norton is also named in the review application although it should be noted that she is not named on the premises licence. The aim of the hearing is not to take action against her or to decide if she is guilty of a crime, the police have included information on her to highlight the fact that there are issues with the way this premises is run and managed.

Consultation

The review application was served by Kent Police on the Fire Brigade, Pollution Team, Planning, Child Protection Services, Weights and Measures and Mr Norton.

The application was advertised at the Council Offices and on the premises for a period of 28 days, in line with the Governments Hearings Regulations.

Conclusion

Kent Police have applied for a review of the premises licence. They are requesting that the licence be revoked. Should members not elect to revoke the licence, the Police request that the DPS must be present when the premises is open, a three month suspension be imposed and 6 conditions be added, these are detailed in their 'Grounds for review' document.

Councillors must decide if any of the following are appropriate:

- Remove/modify any of the current licensable activities.
- Remove/modify any of the licence conditions.
- Remove the Designated Premises Supervisor. (following the 21 day appeal process and any subsequent appeal by Swale Police or Mr Norton)

Grounds to review (Crown)

The premises known as the "The Crown Hotel" is situated at 148 High Street, Sheerness. The venue has a number of hotel rooms above the bar area although at this time they are not in use. Therefore at the moment the venue consist of a single room bar area with a private function room at the rear. The premises licence is owned by Steven Norton.

We believe the premises are no longer suitable to be run as a public house as they have become a venue for the trading of stolen goods and we suspect the supply of drugs. This information comes from a recently run Police Operation in Sheerness to tackle Serious Acquisitive Crime, it should be mentioned that intelligence reports had linked this type of crime with the supply of Class A and Class B drugs in the Swale area. This point is important to note as there is evidence that drug dealing was also going on at the premises albeit by customers

In May 2010 Kent Police Launched "Operation Invoice" with the intent of tackling/reducing Serious Acquisitive Crime and it followed a government report that highlighted crime in the Swale area. The Operation involved the introduction of Law Enforcement Officers into the Sheemess area whose briefing was to befriend local drug users as they were suspected to be most involved in crime. (For this report these Officers will be referred to as TPO, signifying Test Purchase Officer)

At the beginning of the operation there was no specific intelligence as to which venues/persons were receiving/handling the stolen goods.

On Wednesday the 30th June 2010 the TPO was with a female who stole some goods from Superdrug, this female then took the items to The Crown Public House where she sold them. During this time the TPO waited outside but when the female came out of the public house, they returned to the shops to steal some more items. These were also sold in the Crown Public House. Having obtained the money the female then arranged to purchase some heroin.

Around 11:15hrs on Tuesday the 7th September 2010 the TPO went into the Crown Public House, they were in possession of several items including toiletries and fragrances. In the public house the TPO spoke to Janet Norton and told her that she had some items stolen from Boots to sell. Janet Norton purchased some of the air fresheners from the TPO. Norton then called over a customer who also purchased some of the goods. Janet Norton then gave the TPO an order of things to steal for her. During the conversation Norton made it clear that she regularly buys stolen goods including items for the public house, Janet Norton spoke of her brother, Steven Norton and indicated that he was a drug user. Janet Norton also purchased some items from the TPO for her sister

On Thursday the 9th September 2010 the TPO returned to the Crown around midday. She had again been supplied with some items including perfume. At the Crown Public House the TPO spoke to Janet Norton and told her that she had some more items for sale and stated that she had stolen everything form Boots. Janet Norton purchased several of the items and then another customer (Different person from the person on the 7/09/10) also bought some of the goods. The TPO left the premises for a short

while to try and sell items at another venue but was then called back by Janet Norton via sending her a text message. The TPO did return and Janet Norton purchased several of the remaining items the TPO had left. Janet Norton then again provided a list of items she wanted stolen for her.

Janet Norton was arrested for handling stolen goods on the 8/10/10 and in interview she admitted to buying the items knowing they were stolen.

At the time of these incidents the nominated DPS of the Crown Public House was a Christina Barnes although in fact she was merely a DPS in name only. She had agreed to Steven Norton's request to be the DPS in return for use of the premises for her son's birthday party. Christina Barnes believed that she would be registered as the DPS for only a few weeks. Christina Barnes has in fact stated that she was not paid to be the DPS and actually had no role in the premises other than to clean it in preparation for her son's birthday party she never undertook the DPS duties, it was Steven Norton who was running the pub on a day to day basis. Other than that Christina Barnes has only visited the venue as a customer.

On Friday the 1st October 2010 the Police conducted a Licensing Visit to the Crown Public House, in the gents toilets the Police noticed a missing tile in the wall, which allowed access to the wall cavity. Within this space the Police found a quantity of clip lock bags. This type of bags is often used in drugs supply, we believe that this is further evidenced by where the bags were found, "hidden" in a wall in the gents.

As can be seen the premises are now linked with the trading of stolen goods and this is in turn linked with the supply of drugs. The TPO was directed to the venue by a very active shoplifter from Sheemess, it wasn't simply a lucky guess that they could unload the goods at that venue. The fact that both staff and customers were involved shows that this is quite common.

Where as we accept that trading in stolen goods goes on in some licensed premises if this behaviour was anything other than the norm I would expect the seller to be approaching the customers and at least some of the more naïve customers asking where it came from, but in this case the customers either approached the seller or were introduced to them by Janet Norton once she had conducted her business the customers knew what was going and simply waited their turn to do their shopping. It should be noted that during Operation Invoice only 2 licensed premises were identified. (Both are subject of similar reviews)

Therefore the Police seek the revocation of the premises license, as we believe the premises are too heavily associated with the handling of stolen goods. This public house is a "regular's pub" with both the venue and the clientele involved. A simple implementation of conditions will not stop this, as the sellers will go where the customers are.

The report, which lead to Operation Invoice linked this type of crime with drugs supply, this is further evidenced by the TPO's evidence from the 30th June 2010. Kent

Police believe these premises are linked to drug supply by the Police evidence from the 1st October 2010.

The Police fully accept that Steven Norton has not been implicated in the purchasing of the stolen goods and in fact he was away in Russia during the 2 purchases from the TPO in September, however from the evidence given by Christina Barnes it can be seen that he was effectively the DPS and therefore had that responsibility, please remember the first evidenced instance of handling the stolen goods happened in June 2010. Steven Norton has either willingly allowed it to go on, after all the conduct was blatant, or if he was ignorant of the activities then he is not competent enough to run the venue again the conduct was blatant and anyone in charge should have been aware. As the premises owner he will always have control over the venue and we do not believe he is suitable to run such an establishment. There is also the issue that Steven Norton allowed the premises to run without a proper DPS, he merely got a name for the paperwork and thought; that would suffice. We believe this shows that Mr Norton wants to run a public house without any care or consideration to the rules or the licensing objectives.

If the Licensing Committee decides not to revoke the Licence then the Police ask for:

- 1) For a Personal Licence Holder to be working at the venue at all times that it is open to the public.
- 2) The Premises Licence to be suspended for 3 months. This will allow time for the clientele to move on from this pub, they will not be willing to wait-out 3 months for it to re-open, effectively it gives the venue a chance to reset, i.e. to change DPS/staff and clientele. We also believe that this will act as a significant deterrent to any new DPS to make sure that the premises are run correctly. We know that the findings of this review are not for the purpose of a punishment but if the DPS is removed then the only person who could claim to be punished by the suspension would be the customers. Long term this would be a benefit.
- 3) The fitting of extensive CCTV. i.e.
 - 1. CCTV to be fitted to a standard agreed to by the police that complies with The CCTV Code of Practice (2008 edition) produced by the Information Commissioners Office, with all public areas, including all access and egress points covered.
 - 2. The CCTV system will be maintained and serviced on a regular basis and records kept to that effect.
 - 3. CCTV shall be operational at all time that members of the public and/or staff are on the premises.
 - 4. Images will be retained for a period of at least one calendar month by whatever means the licence holder deems appropriate.

- 5. The Police or Local Authority will have access to these images at any reasonable time and in any case within 48 hours of the request for the image being made.
- 6. The Police or Local Authority will be allowed to take a recording by way of tape, CD Rom or any other means of the image within 48 hours on the initial request being made by either the Police or Local authority.

We also ask the Licensing Review Panel to understand that with this type of Police Operation there is relatively little information that can be passed over. The vast majority of the evidence was provided to us in a statement from DI Kris Hill who is the Officer in overall command of the operation, however he is not a direct witness to any of the events. Therefore we can only supply copies of that statement (appendix A) along with a statement from PC Heather which covers the Licensing visit on the 1st of October 2010 (appendix b). Also included is a statement from Christina Barnes, which covers her position as nominated DPS (appendix C)



Grounds to review (Crown)

The premises known as the "The Crown Hotel" is situated at 148 High Street, Sheerness. The venue has a number of hotel rooms above the bar area although at this time they are not in use. Therefore at the moment the venue consist of a single room bar area with a private function room at the rear. The premises licence is owned by Steven Norton.

We believe the premises are no longer suitable to be run as a public house as they have become a venue for the trading of stolen goods and we suspect the supply of drugs. This information comes from a recently run Police Operation in Sheerness to tackle Serious Acquisitive Crime, it should be mentioned that intelligence reports had linked this type of crime with the supply of Class A and Class B drugs in the Swale area. This point is important to note as there is evidence that drug dealing was also going on at the premises albeit by customers

In May 2010 Kent Police Launched "Operation Invoice" with the intent of tackling/reducing Serious Acquisitive Crime and it followed a government report that highlighted crime in the Swale area. The Operation involved the introduction of Law Enforcement Officers into the Sheemess area whose briefing was to befriend local drug users as they were suspected to be most involved in crime. (For this report these Officers will be referred to as TPO, signifying Test Purchase Officer)

At the beginning of the operation there was no specific intelligence as to which venues/persons were receiving/handling the stolen goods.

On Wednesday the 30th June 2010 the TPO was with a female who stole some goods from Superdrug, this female then took the items to The Crown Public House where she sold them. During this time the TPO waited outside but when the female came out of the public house, they returned to the shops to steal some more items. These were also sold in the Crown Public House. Having obtained the money the female then arranged to purchase some heroin.

Around 11:15hrs on Tuesday the 7th September 2010 the TPO went into the Crown Public House, they were in possession of several items including toiletries and fragrances. In the public house the TPO spoke to Janet Norton and told her that she had some items stolen from Boots to sell. Janet Norton purchased some of the air fresheners from the TPO. Norton then called over a customer who also purchased some of the goods. Janet Norton then gave the TPO an order of things to steal for her. During the conversation Norton made it clear that she regularly buys stolen goods including items for the public house, Janet Norton spoke of her brother, Steven Norton and indicated that he was a drug user. Janet Norton also purchased some items from the TPO for her sister

On Thursday the 9th September 2010 the TPO returned to the Crown around midday. She had again been supplied with some items including perfume. At the Crown Public House the TPO spoke to Janet Norton and told her that she had some more items for sale and stated that she had stolen everything form Boots. Janet Norton purchased several of the items and then another customer (Different person from the person on the 7/09/10) also bought some of the goods. The TPO left the premises for a short

while to try and sell items at another venue but was then called back by Janet Norton via sending her a text message. The TPO did return and Janet Norton purchased several of the remaining items the TPO had left. Janet Norton then again provided a list of items she wanted stolen for her.

Janet Norton was arrested for handling stolen goods on the 8/10/10 and in interview she admitted to buying the items knowing they were stolen.

At the time of these incidents the nominated DPS of the Crown Public House was a Christina Barnes although in fact she was merely a DPS in name only. She had agreed to Steven Norton's request to be the DPS in return for use of the premises for her son's birthday party. Christina Barnes believed that she would be registered as the DPS for only a few weeks. Christina Barnes has in fact stated that she was not paid to be the DPS and actually had no role in the premises other than to clean it in preparation for her son's birthday party she never undertook the DPS duties, it was Steven Norton who was running the pub on a day to day basis. Other than that Christina Barnes has only visited the venue as a customer.

On Friday the 1st October 2010 the Police conducted a Licensing Visit to the Crown Public House, in the gents toilets the Police noticed a missing tile in the wall, which allowed access to the wall cavity. Within this space the Police found a quantity of clip lock bags. This type of bags is often used in drugs supply, we believe that this is further evidenced by where the bags were found, "hidden" in a wall in the gents.

As can be seen the premises are now linked with the trading of stolen goods and this is in turn linked with the supply of drugs. The TPO was directed to the venue by a very active shoplifter from Sheemess, it wasn't simply a lucky guess that they could unload the goods at that venue. The fact that both staff and customers were involved shows that this is quite common.

Where as we accept that trading in stolen goods goes on in some licensed premises if this behaviour was anything other than the norm I would expect the seller to be approaching the customers and at least some of the more naïve customers asking where it came from, but in this case the customers either approached the seller or were introduced to them by Janet Norton once she had conducted her business the customers knew what was going and simply waited their turn to do their shopping. It should be noted that during Operation Invoice only 2 licensed premises were identified. (Both are subject of similar reviews)

Therefore the Police seek the revocation of the premises license, as we believe the premises are too heavily associated with the handling of stolen goods. This public house is a "regular's pub" with both the venue and the clientele involved. A simple implementation of conditions will not stop this, as the sellers will go where the customers are.

The report, which lead to Operation Invoice linked this type of crime with drugs supply, this is further evidenced by the TPO's evidence from the 30th June 2010. Kent

Police believe these premises are linked to drug supply by the Police evidence from the 1st October 2010.

The Police fully accept that Steven Norton has not been implicated in the purchasing of the stolen goods and in fact he was away in Russia during the 2 purchases from the TPO in September, however from the evidence given by Christina Barnes it can be seen that he was effectively the DPS and therefore had that responsibility, please remember the first evidenced instance of handling the stolen goods happened in June 2010. Steven Norton has either willingly allowed it to go on, after all the conduct was blatant, or if he was ignorant of the activities then he is not competent enough to run the venue again the conduct was blatant and anyone in charge should have been aware. As the premises owner he will always have control over the venue and we do not believe he is suitable to run such an establishment. There is also the issue that Steven Norton allowed the premises to run without a proper DPS, he merely got a name for the paperwork and thought; that would suffice. We believe this shows that Mr Norton wants to run a public house without any care or consideration to the rules or the licensing objectives.

If the Licensing Committee decides not to revoke the Licence then the Police ask for:

- 1) For a Personal Licence Holder to be working at the venue at all times that it is open to the public.
- 2) The Premises Licence to be suspended for 3 months. This will allow time for the clientele to move on from this pub, they will not be willing to wait-out 3 months for it to re-open, effectively it gives the venue a chance to reset, i.e. to change DPS/staff and clientele. We also believe that this will act as a significant deterrent to any new DPS to make sure that the premises are run correctly. We know that the findings of this review are not for the purpose of a punishment but if the DPS is removed then the only person who could claim to be punished by the suspension would be the customers. Long term this would be a benefit.
- 3) The fitting of extensive CCTV. i.e.
 - CCTV to be fitted to a standard agreed to by the police that complies
 with The CCTV Code of Practice (2008 edition) produced by the
 Information Commissioners Office, with all public areas, including all
 access and egress points covered.
 - 2. The CCTV system will be maintained and serviced on a regular basis and records kept to that effect.
 - 3. CCTV shall be operational at all time that members of the public and/or staff are on the premises.
 - 4. Images will be retained for a period of at least one calendar month by whatever means the licence holder deems appropriate.

- 5. The Police or Local Authority will have access to these images at any reasonable time and in any case within 48 hours of the request for the image being made.
- 6. The Police or Local Authority will be allowed to take a recording by way of tape, CD Rom or any other means of the image within 48 hours on the initial request being made by either the Police or Local authority.

We also ask the Licensing Review Panel to understand that with this type of Police Operation there is relatively little information that can be passed over. The vast majority of the evidence was provided to us in a statement from DI Kris Hill who is the Officer in overall command of the operation, however he is not a direct witness to any of the events. Therefore we can only supply copies of that statement (appendix A) along with a statement from PC Heather which covers the Licensing visit on the 1st of October 2010 (appendix b). Also included is a statement from Christina Barnes, which covers her position as nominated DPS (appendix C)

In the spring of 2010, Kent Police embarked on a lengthy covert investigation called Operation Invoice.

In the months preceding this investigation, the Swale District was experiencing the largest rise in house burglaries of any District in Kent. The Home Office's own data comparing Swale with 14 similar Districts across England and Wales ranked Swale 13th out of 15 for the volume of burglary offences.

In a Home Office survey before Operation Invoice, twice the number of respondents in Swale considered 'Drug Dealing or Misuse to be a big problem in their local area', than respondents nearby in Maidstone.

Intelligence indicated a strong association between the commission of Serious Acquisitive Crime and the Supply of Class A and B Drugs throughout Swale.

The outcome of Operation invoice has confirmed that the ready supply of Class A Drugs in the District has fuelled the increase of Serious Acquisitive Crime.

Similarly, the propensity among some to profit from the proceeds of that Serious Acquisitive Crime has encouraged the steady supply of Class A drugs.

This case is one of many that are the culmination of the Operation Invoice investigation. Collectively these cases have contributed to the network of drugs and crime that has existed in Swale in recent years.

Test Purchase Officers (referred to as "T.P.O.'s") were deployed from MAY 2010 into the area of the Isle of Sheppey and Sittingbourne.

The officers engaged in the operation will only be identified by their pseudonyms. In this particular part of the investigation the relevant officer is "TPO Connie".

Janet Norton is the sister of Steven Norton who is the owner of the Crown Hotel public house in Sheerness High Street. Janet Norton worked at the venue behind the bar.

This public house is being used as an outlet by local thieves to sell stolen property to both the staff (Janet Norton) and the customers. It is also evident that Janet Norton was providing lists of items to be stolen for her.

On Wednesday the 30th June 2010 TPO Connie met up with a female named Shona Connor in Sheerness. This female stated that she needed to go to Superdrug and so TPO Connie went with her. At Superdrug the Connor stole a bottle of Sun Cream. She then told the TPO that she had to go and sell the items and they walked to the Crown Public House. The female went inside as TPO Connie waited outside. A short while later Connor came out of the pub and told TPO Connie that she needed to go and get some more stuff. They then walked back to the shops where Connor stole several more items from different shops. She and TPO Connie retuned to the Crown Public House and again the TPO waited outside.

Connor came out of the Crown Hotel and told TPO Connie that she had made £43, she then made a phone call to her dealer and arranged to pick up two bags of heroin. The conversations and meetings were recorded and exhibited as C/300610/1456.

Both the customer and Janet Norton enquired about the prices of various items and the customer purchased the aftershave. Janet Norton told TPO Connie that she never buys things from shops. Janet Norton then said that she wanted Ck Eternity and some linen trousers in size 12 for her and some clothes for her 16year old daughter who is also a size 12. Janet then told TPO Connie that a male comes into the pub quite a lot and sells them meat and that she buys airwicks from Shona who sells them at half price. Janet Norton then told TPO Connie that her brother owned the pub and that he was called chunky she also said that he was 44 years old and a skaghead. Janet Norton also tried to contact a friend whom she thought would be interested in some of the items but couldn't get hold of them. TPO Connie was then approached by a male who identified himself as Kai and he purchased TLE/125. Janet Norton asked TPO Connie to return after she had seen Lisa at the Old House at Home. TPO Norton left the Crown and went to the Old House at Home next door but at 12:13hrs she received a text message from Janet Norton saying, "come back". TPO Connie then returned to the Crown Hotel and showed Janet Norton what items she had left. Janet Norton then bought 3 more items and told TPO Connie that she wanted some trousers, jeans and cardigans all size 12. She also wanted some Joop. stupid. She also admitted to giving TPO Connie a list of items she would buy if Connie were able to get them.

Janet Norton was charged on the 8th October 2010 with one count of intentionally encouraging the commission of an offence and three counts of attempting to handle stolen goods. She was granted bail to appear at Sittingbourne Magistrates Court on the 25th October 2010.

This premises is implicated in the trade of stolen goods that has fuelled the crime and drugs network in Sheerness prior to Operation Invoice. The activity on the 30th June highlights the challenge facing this community very well. A known thief was using this public house as an outlet for her stolen property, and was given lists of property to steal. Immediately after converting her stolen items into cash, she contacted her drug dealer and purchased 2 bags of heroin.

The cyclical nature of crime to fund drug addictions was the root cause of the problems being experienced on the Isle of Sheppey in the months preceding this operation.








Mandatory Conditions:

- No sale of alcohol can take place where the designated premises supervisor is not a personal licence holder.
- Any door supervisors must be trained and SIA registered.
- (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
 - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
 - (i) the outcome of a race, competition or other event or process, or
 - (ii) the likelihood of anything occurring or not occurring;
 - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

• The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

The responsible person shall ensure that-

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and
- (b) customers are made aware of the availability of these measures




Part 4

Conditions consistent with the operating schedule:

- o CCTV is to be installed in agreement with the police and will cover all exits and entrances and public areas of the licensed premises.
- All CCTV cameras and recording equipment, including video tapes if used, are to be well maintained, kept in good working order and are to be subject to regular testing and inspection, which will be auditable.
- Any recording made via the use of the CCTV will be retained and stored for a minimum of 30 days and made available to the police or local authority on request or in any case within 48 hours of a request being made.
- Any person leaving the licensed premises (excluding the yard area next to the function room) will not be permitted to remove or take with them any bottles or open container that contain or have contained beverages of any kind purchased in the licensed premises.
- Door Staff will be in place from 20:00hrs whenever the premises trade for the sale of alcohol past 23:00hrs, to close of premises.
- Door Staff will wear clothing that is easily identifiable on CCTV such as reflective coats or reflective armbands.
- o If permitted to be a member of the Swale Safe radio system, the premises license holder will ensure active participation.
- o No children will be allowed on the premises unless accompanied by an adult.
- o No children will be allowed on the premises after 18:00hrs unless attending a function.
- o Windows and doors will be closed from 23:00hrs, except for entry and egress.
- All doors and windows to remain closed, except for access and egress when regulated entertainment is taking place.
- Last entry to the premises will be 23:30hrs on a Friday and Saturday night.
- Regular toilet checks will be made to prevent and deter drug use in the premises and these checks recorded.
- Access to the premises will be allowed to the police at any reasonable time in order for swabs to be taken for testing in the Ion Track Drug Trace machine.
- o Drinks promotions will not be permitted allowing unlimited supply of alcohol for a set price.
- o All staff will be fully trained in licensing law and that training will be auditable.
- All staff will be fully trained in the 'Challenge 21' scheme and will be instructed to ask for identification from any person attempting to buy or consuming alcohol who appears to be under the age of 21.

- The forms of identification that will be acceptable will be photographic ID such as a passport, photographic driving licence or a 'PASS' approved proof of age card such as the 'Prove It' card.
- O Any DJ providing entertainment that falls under the category of 'Making Music' shall be restricted to the rear function hall, Karaoke is permitted in both the rear function hall and front bar.
