Background

The Licencee of The Phoenix Tavern, Faversham has applied to vary the existing Premises Licence for the premises in Abbey Street, Faversham. The Phoenix Tavern is a public house Circa 1300 situated just off the town centre of Faversham in the residential area of Abbey Street. The garden is to the rear of the property and is accessed either through the premises of via Vicarage Street, which runs behind it. To the side of the premises is a small car park. There is no front garden.

The premises licence was granted in June 2005 under Grandfather Rights. The licencee at the time operated a 'food led' business and did not utilise the outside space. The current licensee purchased and took over the premises two years ago, he now seeks to licence the rear garden for 'English Garden Music', primarily on a Sunday afternoon during the summer months although he also wishes to have music in conjunction with festivals such as the Hop Festival each September. Temporary Event Notices could be applied for each time, however as members are aware TEN's cannot be conditioned or refused and it was the opinion of the Councils Licensing Enforcement Officer that a full variation should be applied for.

Consultation

The application was served by the applicant on Kent Police, Kent Fire and Rescue, the Councils Pollution Team, Planning, Child Protection Services and Weights and Measures.

The application was advertised in the local paper and on the premises for a period of 28 days, in line with the requirements of the Licensing Act 2003. Although not a requirement of the Licensing Act, the applicant also sent out a letter to local residents giving further details of his application (see attached).

Eight objection letters were received from local residents the letters cite concerns over potential noise nuisance from the garden over the summer each year. Six letters of support have also been received.

The Environmental Pollution Team have also raised concerns over potential noise (see attached report)

Swale Police did not raise any objection to the application as there is no history of problems with crime and disorder at the premises.

Conclusion

The licencee of the Phoenix Tavern has applied to vary the existing premises licence to include regulated entertainment in the garden during summer months (April – September) each year. Eight local residents and the Environmental Pollution Team have raised objections. Six local residents have sent letters in support.

Councillors must decide if any of the following are appropriate:

- Grant the variation as applied for.
- Grant the variation with conditions and/or changes.
- Refuse the variation.





 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
 - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on—
 - (i) the outcome of a race, competition or other event or process, or
 - (ii) the likelihood of anything occurring or not occurring;
 - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the

effects of drunkenness in any favourable manner.

- The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.


- The responsible person shall ensure that—
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) customers are made aware of the availability of these measures.


As you are aware I have previously complained about the loudness, behaviour and bad language of the garden drinkers.

The Phoenix Tavern, 96/98 Abbey St. Faversham - regarding Noise Pollution, emitting from their rear garden.

Living where I do, close to the Phoenix Tavern and the Noise that emits from the Pub Garden, I have already sent two letters of strong complaint to Swale Borough Council. These letters dated 6-9-2010 and 5-9-2011, plus several telephone calls to Mr Michael Moss, who has been most helpful. My letters should be on file, if not, I can supply copies. From the dates of my written complaints, it will be apparent that these followed the Annual Faversham Hop Festival, that I of course make allowance for, and Faversham being a Brewery Town. It is the Noise levels that I feel are unnecessary, more suited to an out of Town "Rave". In addition to the Hop Festivals there have been several other occasions when the Phoenix has had "Music", blaring from their garden - some without legal permission. On one or two such events, the noise levels were acceptable, as they were seemingly purely Instrumental, with softer solo Artists and I think a Jazz Band. I would think that on these occasions that the music/sound was unamplified and even so, went on until later than I would have wished. It is the amplified Rock type

music, with the loud announcements and increased screaming & shouting

as patrons imbibed more alcohol, that was unbearable to me, with my little house actually vibrating at times.

Thus, it is with horror that I view the current Application, by the Phoenix Tavern for a Premises License Variation. Namely that they are given permission to have Plays, Live Music, Recorded Music and Dancing, outdoors during the Summer months. April to September, Monday to Sunday from mid-day until 8pm. (1200-2000 hrs). I can only pray that such "Carte Blanche" permission is NOT granted, or the lives of residents, hereabouts will be made a misery, possibly every day for 6 months. The Phoenix is located in the midst of a closely concentrated Residential area, and prior to the present ownership/management of the Pub, there was no noise or troublesome behaviour from it. It changed ownership, I believe about the end of 2009/ beginning 2010. It is now of increased status & I would imagine increased profits - all to the good, being a successful business. However, I do not feel it ethical that they should further persue this at the expense of their neighbours. ME ! ! My small 2 up 2 down in Vicarage St was built circa 1890 and of single wall brick and even my double-glazing does not shut out the noise. Also I do not want to be compelled to keep my windows shut during the Summer months. I retired here to what was a peaceful area and I resent the selfish actions of the Phoenix Tavern, thus I earnestly trust that you will take my considerations into account, when deciding their Application to "do as they please" in varying the Pub's License.

Following my 11-11-2011 letter of objection, regarding the current application by The Phoenix Tavern to vary their Premises License, I now enclose a copy letter, from The Phoenix, and put through my door on 12-11-2011. My comments relating to this letter, follow and I ask that you please append these to my 11-11-2011 objections.

In their letter to their "Neighbours", dated 12th November, the Phoenix states that " by and large, they are not a music pub and no intention to change this" Why? then are they now seeking permission to have music in their rear garden, April to September, Monday to Sunday. 12.00 to 20.00. I see this as a contradiction. The writer then states, that on Hop Festival dates, whilst sitting in the Pub's garden, he/she can hear "bands all over town" - after music at The Phoenix has ended. Well, here in Vicarage St. - it is noise coming from the Phoenix that affects me, and as previously said, I make allowance for the Hop Festival. It is the incremental steps being taken by The Phoenix, to change it, very apparently to a "music venue". that concerns me.

They then describe, their contemplating "gentle English garden music, striped blazers and boaters maybe" I see this as far-fetched, would that it were not. The Phoenix, then make great play of what they do not do. "No fruit machines, no juke boxes, no mass sport on large

screen TVs around the bars, no computer games & no alcopops. Were such activities in place, these would not concern me, being INSIDE their Premises. (Indeed, whatever difference, does not selling "alcopops make? They are a Pub and as to be expected retail all manner of strong spirits and liquor.) I am perplexed as to how, by making these irrelevant points, The Phoenix might be enabled to increase the amount and frequency of offensive noise, from OUTSIDE their Premises?

I therefore ask that you please take both my letters into account, when considering this current application by The Phoenix to vary their Premises License.

Beer Garden gates are shut on a Fri and Sat evening and there is no longer the noise incidents in our street that the residents were subjected to in the previous year.

I object to the above Application dated 5 November 2011 because it is asking too much an everyday outdoor music licence for 6 months of the year and would effect the quality of life for the residents living in the proximity.

Application for outside live amplified music, Monday to Sunday in summer months from Midday to 20.00 hours

We wish to formally object to this application. The garden is in close proximity to a number of houses and if not suitably controlled could cause a lot of problem from both amplified music and behavioural noise. The application is very wide in its times and days and if granted, could allow disturbance to neighbours on a daily basis all through the summer months. We certainly could not support this.

Any music would be clearly audible in neighbouring properties and there are no measures given in the operating schedule to mitigate for or minimise the potential noise. Playing live music outside in this location is likely to give rise to justifiable noise complaints.

Four noise complaints have been received concerning this premises in 2010 and two in 2011, some of these complaints related to music at festivals being played in the rear garden.

We therefore object to a licence that allows for the use of the outside area for the playing of live and recorded music on the grounds of public nuisance and recommend the variation is **refused**.

We do recognise that Members may wish to grant the variation once all the evidence has been put before them. If this is the case we strongly urge that strong control measures are put in place.

It is noted that there is a letter circulated to residents referring to only having jazz concerts on a Sunday lunchtime and a festival in May and at the Hop Festival weekend. The letter also points out the current operation of The Phoenix. Whilst the premises may be run well and with concerns for the neighbours, we would be worried about the premises changing hands if the variation was too wide open and permanent.

Thus it is recommended that any variation and conditions should be applied to the present Licence Holder only. If the Licence Holder leaves, the variation ceases to operate. Any future variation can then be considered on its own merits.

The question of having every Sunday for live amplified music has been considered and due to the audibility of music and announcements, it is recommended that this should be reduced to just four events per year and only take place outside on one per month between 1st May and 1st weekend of September. This should be non consecutive Sundays i.e. not the last of one month and first of the next. This arrangement could include two outside festivals on single days in any one year.

Which ever days are chosen, residents and the Environmental Protection Team are to be advised in writing at least 21 days prior to any event. Also, it is strongly recommended that no amplified music should be played before Midday and finish not later than 18.00 hours.

It must again be emphasised that any amplified music will be audible in the neighbouring properties and the residents must be protected.
