# 1. Purpose of Report and Executive Summary

1.1.1 This report concerns the Hearing of the Complaint of Member Misconduct: SBC 02.12. It presents the Investigator's report, which found that there has been a breach of the Members' Code of Conduct. The Sub-Committee is asked to determine whether there has been any breach, or breaches, of the Code of Conduct. If it finds that there has been a breach, then to determine what sanction, if any, should be imposed.

## 2 Background

2.1 On the 28 February 2012, the Standards Referrals Sub-Committee considered the complaint of alleged misconduct. The decision of the Standards Referrals Sub-Committee was to refer the complaint to the Monitoring Officer for investigation. On the 4 September 2012, the Standards Consideration and Pre-

hearing Sub-Committee considered the Investigator's Report and decided that it should be referred to a hearing.

### 3 Proposals

- 3.1 The Investigator found that there had been a breach of the Code. The Standards Hearing Sub-Committee is now being asked to hear the matter and decide whether or not there has been a breach, or breaches, of the Code of Conduct. If it determines that there has been a breach, the Sub-Committee must consider what sanction to impose, if any.
- 3.2 The Investigator's Report is attached as exempt Appendix I. Members will see from the Pre-Hearing Process Summary and forms completed by the Subject Member [Appendices III(a) and (b)] that he disagrees with some of the Investigator's findings of fact and denies being in breach of paragraphs 9 and 12 of the Code of Conduct.
- 3.3 The Hearing Procedure for this Sub-Committee is attached as Appendix IV.

#### 4 Alternative Options

4.1 The proposals in this report are subject to the transitional arrangements set down in article 7 of the Localism Act 2011 (Commencement No. 6 and Transitional, Savings and Transitory Provisions) Order 2012. These arrangements are mandatory so a departure from these proposals would not be recommended.
