





## Proposed Parking Restrictions The Butts, Sittingbourne

Swale Borough Council are proposing to install double yellow lines on both sides of the road, at The Butts, Sittingbourne, from the rear of Icelands to the junction with Crown Quay Lane.

It is proposed to introduce these parking restrictions to keep this narrow road clear of parked vehicles to enable delivery vehicles to gain access to the rear of the cinema and bingo hall. 
