

# Proposed Extension to School Keep Clear Markings Seasalter Road, Graveney – Revised Proposal

Following a request from Graveney Primary School, the Borough Council is proposing to extend the existing School Keep Clear Markings in Seasalter Road by approximately 20 metres in a **southerly** direction.

The purpose of this proposal is for the lining to extend across the pedestrian crossing point, to keep it clear of parked vehicles during school drop off and collection times.



Following this consultation we received a couple of objections and the proposals were therefore not progressed, but we have now received another request from a resident following a road traffic accident at this location.



Following several requests from residents in the area, the Borough Council is planning to install double yellow lines along a couple of sections of Fairview Road as shown on the plan overleaf.



Following a request from a local resident, the Borough Council is proposing to install School Keep Clear Markings in Bellevue Road, Minster.



Following a request from a local resident, it is proposed to replace the existing single yellow lines in Abbey Street, near the junction with Lammas Gate, with double yellow lines.






As part of these proposals, the Borough Council has been asked to progress the re-location of the existing School Keep Clear markings from the western end to the eastern end of the school frontage, to keep this section of School Lane clear for a proposed school crossing patrol. The restrictions will be the same as those already in place, and will restrict parking between 8.30 - 9.30am and 2.30 - 5.00pm Monday to Friday during school term time.


These proposals have been requested to improve safety by ensuring the junction is kept free of parked vehicles.





# Proposed Double Yellow Lines Church Farm Road/Forge Lane/Chaffes Lane, Upchurch

Following a meeting with representatives from Holywell Primary School, Upchurch Parish Council, the Police and Swale Borough Council, it is proposed to install double yellow lines on the junctions of Church Farm Road and Forge Lane, and Church Farm Road and Chaffes Lane.

These restrictions have been proposed to improve vehicle movement in the area, particularly during school drop-off and collection times, by keeping these junctions clear of parked cars. In addition to this, we have been requested to extend the proposed double yellow lines from Church Farm Road around the bend in Chaffes Lane, where problems with parked vehicles have also been reported.
