



## **Proposed Waiting Restrictions Lower Road/Selby Court, Teynham FIRST CONSULTATION**

A request has been received by our Parking Manager for double yellow lines to be introduced on the north side of Lower Road, between the junctions of Conyer Road and Selby Court in Teynham.

It is reported that there is a potential problem with vehicles parking close to these junctions obstructing the sightline of vehicles, and it has been proposed to introduce double yellow lines as shown on the plan on the other side of this sheet. The existing waiting restrictions are shown in mauve, and the proposed double yellow lines are shown in red.

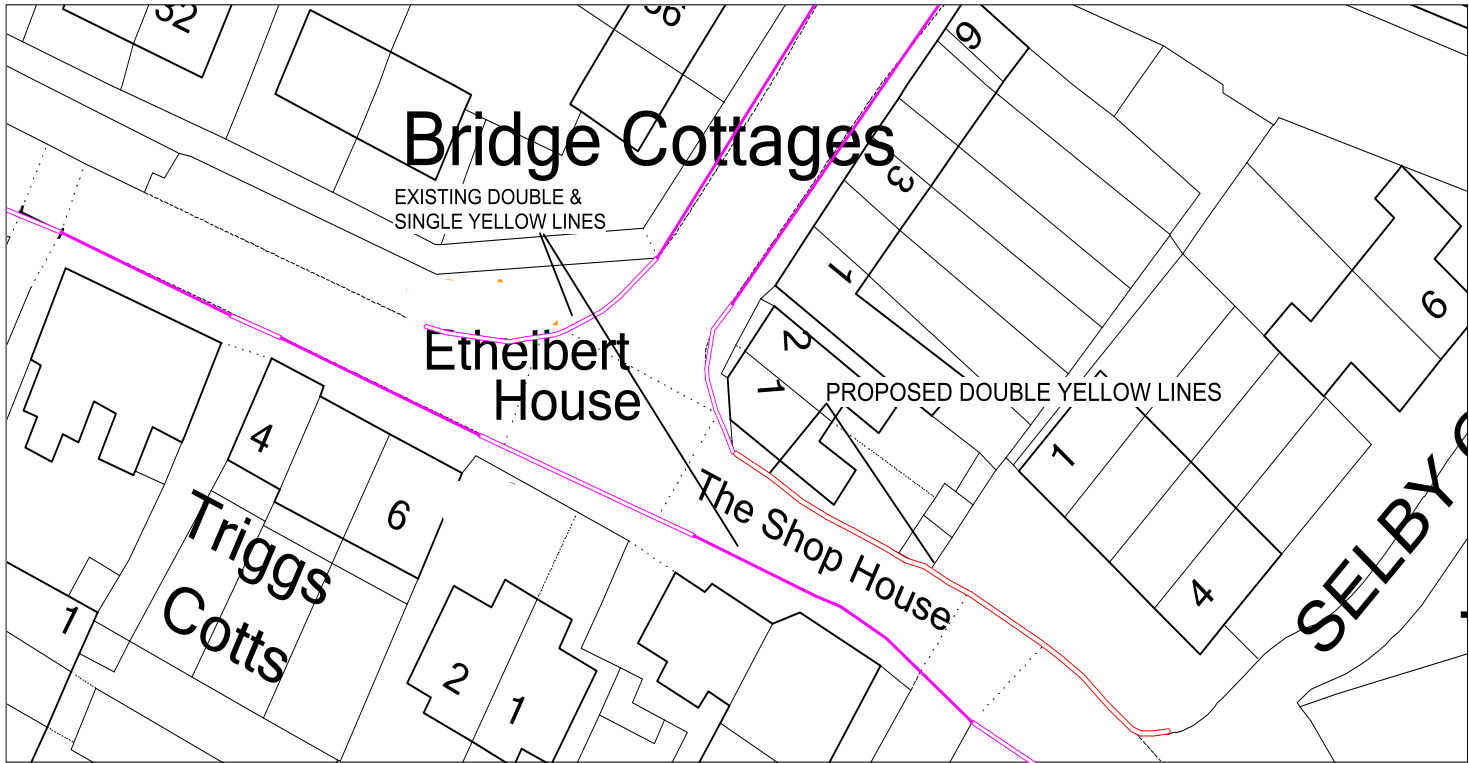

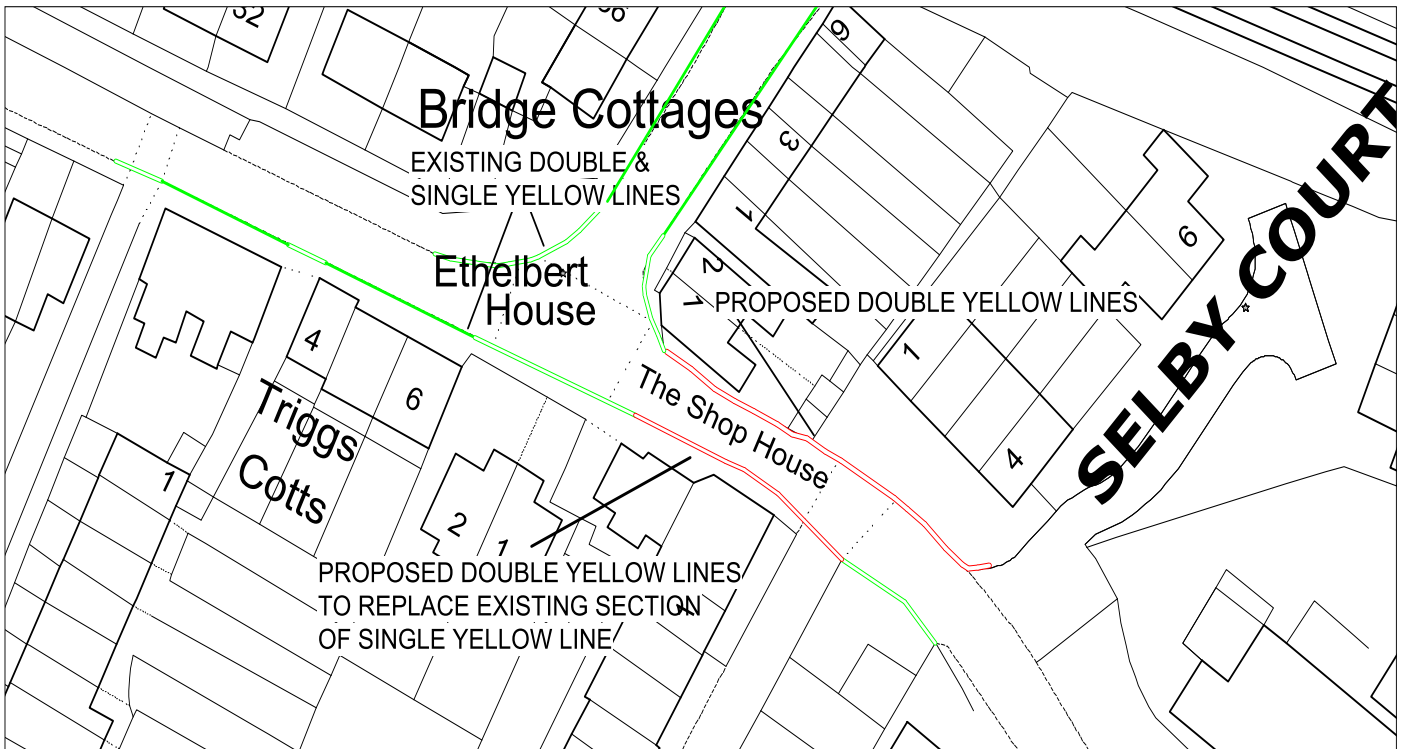
