3. Declarations of Interest

The Chairman will ask Members if they have any interests to declare in respect of items on this agenda, under the following headings:

- (a) Disclosable Pecuniary Interests (DPI) under the Localism Act 2011. The nature as well as the existence of any such interest must be declared. After declaring a DPI, the Member must leave the meeting and not take part in the discussion or vote. This applies even if there is provision for public speaking.
- (b) Disclosable Non Pecuniary (DNPI) under the Code of Conduct adopted by the Council in May 2012. The nature as well as the existence of any such interest must be declared. After declaring a DNPI interest, the Member may stay, speak and vote on the matter.

Advice to Members: If any Councillor has any doubt about the existence or nature of any DPI or DNPI which he/she may have in any item on this agenda, he/she should seek advice from the Director of Corporate Services as Monitoring Officer, the Head of Legal or from other Solicitors in Legal Services as early as possible, and in advance of the Meeting.

During public session, members of the public living in the Borough of Swale may make a statement, submit a petition, or ask the Chairman any question on any matter on which the Council has powers or duties, in respect of rural matters.

Questions or statements shall be read at the meeting and shall not last more than three minutes. An answer from the Chairman may take the form of a direct oral answer or be in writing. 

The Leader Programme 2014-2020 "UPDATE"

What is the Leader Programme?

The Rural Development Programme for England (RDPE) LEADER Programme is a European Union rural funding approach, with a total of £5million in grant funds available from January 2015 to December 2020.

The RDPE LEADER is a way of spending money on local issues, identified by people living in that area.

The money is locally controlled, with decisions about which projects are funded being made by the Local Action Group (LAG) for the LEADER area.

Funding under Leader is available to rural businesses, farmers, foresters, growers, landowners, environmental organisations, cultural, heritage and community providers, as well as voluntary and charitable organisations to develop projects that will assist, strengthen and develop themselves and their local area.

The six priorities for Leader under the new Programme are;

- Support for increasing farm productivity
- Support for micro and small enterprises and farm diversification
- Support for rural tourism
- Provision of rural services
- Support for cultural and heritage activity
- Support for increasing forestry production

The Leader bids for West Kent, Kent Downs and Marshes Leader and East Kent were submitted on 5th September. A national panel of senior Defra officers will be judging each Leader bid in an 'open and transparent' manner and making their decision on whether to award funds or not. There have been 87 bids from all over England and Defra hope to whittle this down to about 70 groups that will be funded. The decision is due in early November (no specific date given) and if successful we will be able to start awarding grants from 1st January 2015. If we are successful we will be looking to prepare potential projects for funding from November onwards so we have some that are 'oven ready' come January.

Swale's bids have been covered by two of the three Leader groups – Kent Downs and Marshes Leader and East Kent Leader. If both bids are successful all of Swale will be covered for potential project funding.

The emphasis of each strategy will be on providing **Jobs and Growth.** This is a requirement set by Defra and each LAG will deliver 70% of project funding directly in support of jobs and growth in the rural economy – using the above six priorities for the new Programme.

This is an important opportunity for business and communities in rural Kent to access over £5 million of grant funding over the next seven years.

The Observer Food Monthly 2014 award winners were announced last week and it was fantastic to see one of the sixteen winners was from our very own borough!

Monkshill Farm in Waterham beat off stiff competition from elsewhere in the U.K to win the judges award for 'Best Local Farmer'. The Royal School for Deaf Children Margate purchased Monkshill Farm in 1995 and it is now part of The John Townsend Trust who have developed it into a strong educational offering whilst maintaining high levels of success and ethics as a working farm.

Winner of the award, Richard Stephens, has managed the farm for the past 11 years and maintains that if you look after your stock, the benefit will be clear on the plate.

True to his word, the welfare of the animals is very apparent. The first thing that will strike anyone arriving at the farm are the chickens, lots and lots of chickens running everywhere! The happy marsh-fed sheep may take an interest in your arrival, albeit briefly, and the spotted pigs will undoubtedly put a smile on anyone's face.

With glorious 360° views of the surrounding landscape and a farm-shop offer that includes fresh meat, scones and a cracking caramelised onion chutney, it's clear to see why they won.
