To approve the Minutes of the Meeting held on 18 November 2014 (Minute Nos. 340 - 348) as a correct record.

3. Declarations of Interest

Councillors should not act or take decisions in order to gain financial or other material benefits for themselves or their spouse, civil partner or person with whom they are living with as a spouse or civil partner. They must declare and resolve any interests and relationships.

The Chairman will ask Members if they have any interests to declare in

respect of items on this agenda, under the following headings:

- (a) Disclosable Pecuniary Interests (DPI) under the Localism Act 2011. The nature as well as the existence of any such interest must be declared. After declaring a DPI, the Member must leave the meeting and not take part in the discussion or vote. This applies even if there is provision for public speaking.
- (b) Disclosable Non Pecuniary (DNPI) under the Code of Conduct adopted by the Council in May 2012. The nature as well as the existence of any such interest must be declared. After declaring a DNPI interest, the Member may stay, speak and vote on the matter.

Advice to Members: If any Councillor has any doubt about the existence or nature of any DPI or DNPI which he/she may have in any item on this agenda, he/she should seek advice from the Director of Corporate Services as Monitoring Officer, the Head of Legal or from other Solicitors in Legal Services as early as possible, and in advance of the Meeting.

Public Session

During public session, members of the public living in the Borough of Swale may make a statement, submit a petition, or ask the Chairman any question on any matter on which the Council has powers or duties, in respect of rural matters.

Questions or statements shall be read at the meeting and shall not last more than three minutes. An answer from the Chairman may take the form of a direct oral answer or be in writing. Questions submitted to the Democratic Services section in writing (including email) at least three days before the meeting will be taken first.



HELP SHAPE THE FUTURE OF YOUR RURAL AREA

Kent Downs and Marshes Leader and the East Kent Leader are looking for new members to join their Local Action Groups (LAGs). The LEADER approach is a way of spending money on local rural issues, identified by people living in the area. This bottom –up approach to local issues leads to locally tailored solutions based on the economic, social and environmental based needs of the Leader area.

The money is locally controlled with decisions about which projects are funded being made by the LAG. Each LAG is made up of representatives from organisations across that Leader area which includes the relevant parts of rural Swale.

Kent Downs & Marshes Leader has been in existence since 2007 and delivered a £1.65m funding programme which ended in 2013. It is about to start a new funding Programme (subject to a successful bid to Defra) which will run up to 2020 and will be joined by the NEW East Kent Leader. As a consequence the LAG for both areas are looking to attract new members from business, social and environmental backgrounds (individuals or groups) to help deliver and shape the new Programme which will be worth £3.28m collectively and will start in early 2015.

This is a voluntary role with no liabilities on membership and will include attendance at up to two meetings a year.

Cllr Andrew Bowles says:

'Swale is keen to ensure that its rural communities have every opportunity to deliver projects that respond to very specific priorities for its local communities and we will continue to work through the programmes to ensure we build on the success of previous programmes'.

Funding for Leader comes from The Rural Development Programme for England 2014 - 2020 and is administered through Defra. Kent County Council is the accountable body for the Leader group. TIME FOR ALTERNATIVE POWER TO HELP YOUR RURAL BUSINESS?

The case for commercial rooftop solar photovoltaics (PV) has so far rested primarily on the green credentials of the technology. The lack of a definitive case for short-term return on investment on the capital costs of installing rooftop PV has been a barrier to widespread uptake.

However, a report published recently suggests that there is now a clear and compelling economic case for its adoption - the cost of solar panels has plummeted so that the potential savings versus rising grid-based electricity bills have increased. The study uncovers that "British businesses could save over £5bn per year in electricity bills, at current price and consumption levels, by installing fully-funded rooftop solar PV systems on south-facing commercial roofs."

With this in mind, it could be worth reading this study on the potential cost savings commercial rooftop solar PV offers and see if it could help you.

BUSINESS SURVEY - RURAL COMMUNITIES OUTCOMES

The results of our Business Survey are in and we are working through the responses as this goes to press. The survey was sent to 3270 Swale businesses by post. There was also the opportunity to for any business based in Swale to respond online through Survey Monkey (the survey was promoted through our e-bulletin, local business networks and SERP). Of those, 294 businesses in Swale responded to the survey.

A total of 731 Rural Businesses were sent a business survey by post and 30 responded (4% of the rural companies approached). All outcomes provide us a baseline for future surveys.

The purpose of the survey was to determine the demographics and health of local business, to determine how they have fared during the recession and of potential for growth in the coming months.

The general consensus amongst these rural businesses is that they are surviving, with business improving/staying the same. We want to help to increase the number of businesses 'improving' in the borough and we continue to look for ways to support rural business.
