Recommendations	 To note the proposed fees and charges for 2016/17 as set out in this report for submission to Council.

1. Purpose of Report and Executive Summary

- 1.1 The report invites Scrutiny Committee to consider the proposals for the level of fees and charges to be levied for the next financial year 2016/17 for submission to Council. Charges will take effect from 1 April 2016.
- 1.2 Appendix I details proposals for the level of fees to be charged in 2016/17 on those services where this Council sets the charges on a service by service basis. Appendix II sets out the fees and charges which are set nationally by Government. Appendix III details the income from fees and charges for services in 2014/15 and the budget for 2015/16.
- 1.3 We have looked very fundamentally at those services where we can determine the charges locally, many of which have not been increased for a number of years. In doing this we have tried to simplify charges and where there are increases it is not proposed that we will apply small incremental charges year on year, rather we will undertake more fundamental reviews every two to four years depending upon the service. We do need to ensure that for discretionary services where there is a choice over whether the local resident does choose to buy the service, they pay a level which covers costs and is reasonable in comparison with neighbouring councils.

2. Background

- 2.1 In 2014/15 the fees and charges covered by this report where the Council sets the level of fees or charges were £2.6m, of which £1.5m relate to car parking. Detailed work is underway on the potential budgetary impact of the proposals.
- 2.2 Managers were asked to review the current schedule of fees and charges for the forthcoming financial year.

2.3 Authorities have a statutory duty to ensure fees are set in accordance with the Local Government Act 2003. This allows local authorities to charge for discretionary services. Discretionary services are those services that a council has the power to, but is not obliged to, provide. A pre-condition to charging is the person has to agree to the provision of the service and they are prepared to pay for it.

3. Proposals

- 3.1 Appendix I details the proposed fees and charges for 2016/17 to be set by the Council and Appendix II those that are set by Government or another external body.
- 3.2 Table 1 lists those charges set by the Council where an increase is not recommended at this time and any increases shown here are due to volume not price increase. Table 2 lists those charges set by the Council where an increase is recommended. Table 3 lists those charges that are either a proposed new charge or a change in a charge is proposed or recommended. Table 4 lists charges where a decrease is being recommended.

Table 1: Fees & Charges where an increase is not being

recommended for 2016/17		
Fee or Charge	Comments	
Residents' Parking Permits (on street)	No increase is proposed. Fees are comparable to neighbouring authorities. It is proposed that work be undertaken to look at differential charging for large transit type vans which take up much more space than normal cars.	
Car Parks Fixed Penalty Notice	No increase is proposed. Charges are by statutory instrument.	
Taxi Licensing	No increase is proposed. It is believed that the current figures are a positive way of stimulating interest in encouraging potential drivers to step forward. A number of company owners have suggested there is a shortage of good drivers so keeping the fees at the same rate is a positive way of assisting with addressing the shortfall and supporting local businesses. Our prices are around 80% of our neighbours. The Hackney Carriage function will be reviewed in 2016.	
Garden Waste Collections (brown bins – domestic)	No increase is proposed. This is the uniform fee agreed by the Mid Kent Waste Partnership. Take up of this service has hugely increased with the new contract and total income received has increased substantially and is forecast to increase by £106,500 in 2016/17.

Fee or Charge	Comments
Radar Key for Disabled Toilets	No increase is proposed.
Beach Huts	No increase is proposed. As this is a new fee and we are still developing the beach hut scheme (with further on site improvements still taking place and a review of toilet provision underway) it is proposed we hold the fee at the current level for another 12 months. Our fees are generally comparable with other areas.
Licensing-Gambling /Liquor/ Scrap Metal/Sex Establishment/Street Trading	The Licensing Service is subject to a fundamental review which involves all licences issued being reviewed. When this has been completed the basis of charging will be re-examined and this will be complete for the 2017/18 fees & charges review.
Annual Animal Licensing	No increase is proposed. Charges are calculated in line with the Government's locally set fee guidance. Benchmarking has taken place against other Kent authorities. Swale Borough Council is in the top half of the table based solely upon licence price. The current fees reflect our costs incurred.
Stray Dog Collection	No increase is proposed. The fees are based upon costs of providing the service and statutory fees. Our fees are similar to other local authorities.
Hire of Halls (Guildhall)	No increase is proposed.
Advertising Fees for Inside Swale	No increase is proposed. Charges are similar to other organisations.
Purchase of Electoral Register	No increase is proposed. Charges are set by Government.
Staying Put Handyperson Rates	No increase is proposed. The fee is set in the Supporting People Contract.
Pre Application Planning Advice	No increase is proposed. Fees are already towards the higher end compared with other Kent councils and the Cabinet Member and Head of Service both believe that further increases could choke off demand and reduce income.
Sale of Ordnance Survey Plans	No increase is proposed. The charge is calculated to cover costs.

Fee or Charge	Comments
Complaints Made under the High Hedges Legislation	No increase is proposed. There has been no change to this charge for several years. The charge is set above average compared to other Kent local planning authorities.
Local Land Charges	No increase is proposed. Charges are set locally based on regulations where recovery of costs should equate to cost of providing the service. HMRC are considering applying VAT to local land charge search fees. Therefore, these fees for 2015/16 and 2016/17 may be subject to changes relating to VAT status in the future. If this becomes the case, the fees will be amended to reflect the change.

3.3 The following is a list of charges where an increase is recommended.

Table 2 : Fees & Charges where an increase is being recommended for 2016/17		
Fee or Charge	Comments	
Car Parks & Season Tickets	There has been no increase in general car parking charges since 2011. In comparison with neighbouring councils, the car parking charges are low. 60% of visits are for 1 hour or less. Car parking charges are therefore increased to bring us more in line with our neighbours and round charges to easier amounts.	
Street Naming & Numbering	No changes except changing a street name where our charge is comparatively low at £500 but we only had one application in the last year. Increased to £600.	
Bulky Waste Collection	Currently £18.60 compared with £23 for Maidstone and Ashford. Only one other Kent council gives a concessionary rate for those on benefits. Proposed to increase to £23 in line with both Ashford and Maidstone to comply with the Mid-Kent Waste agreement for uniform prices. £23 is still the cheapest rate in the county. All concessions for benefit recipients to be removed.	
Wheeled Bins	Charges based on current Biffa and Eastern Shires Purchasing Organisation (ESPO).

Fee or Charge	Comments
Sports Facilities	Small increases proposed. Charges are generally similar to neighbouring authorities. This service operates at a substantial loss but clearly is of major benefit to sports groups in the borough. A full review will be undertaken in 2016.
Allotments	This service is operated in non-parished areas or where a site is no longer self-managed. Income is around \pounds 1,200 and costs \pounds 12,000 - this position will worsen with transfers out. Our fees are generally comparable to most neighbouring authorities. Small increases applied.
Cemeteries Burial Fees	This service is being run at a very substantial excess of costs over income. It has become increasingly difficult to compare with other authorities as there are numerous variations in the pricing structure adopted by different councils. It is therefore proposed that a full review of the fees and charges is undertaken during 2016. Small increases applied.
Seafront Memorial Bench	Small increase proposed. A community consultation was undertaken earlier in 2015 which included comparison of charges in other areas. Income does cover costs.
Harbour Facilities	Small increase proposed.
Travelling Fairs and Fetes	Small increase proposed. Charges compared with other authorities as a basis for increasing the pitch premium and maintaining the remainder of our charges.
Access over Open Space Licence	Small increase proposed.
Food Export Certificate	Proposed increase of 11.1%. The charge is calculated to reflect the time, travel and administration of the certificate in line with Maidstone Borough Council and Tunbridge Wells Borough Council.
Chartered Institute of Environmental Health Level 2 Award Training in Food Safety in Catering	The increase in charge will bring Swale food hygiene training in line with Tunbridge Wells Borough Council, Maidstone Borough Council and commercial training companies.
Registration Fee under the Local Government (Miscellaneous Provisions) Act 1982	Small increase proposed. Other local authorities' fees and charges have been taken to inform the level of the charge.

Fee or Charge	Comments
Fixed Penalty Notices – Environmental	Smoke free penalty charges are set by Government. The remainder of the charges are agreed locally by members. For all locally set amounts, Swale Borough Council is at the upper limit. New charges have been added to reflect the new legislation that has been introduced (e.g. Community Protection Notices). The lesser limit for early payment has been removed for other Fixed Penalty Notices.
Pest Control	Prices have not increased for several years. The proposed increases are based on cost of providing the service. Recent increases requested by service provider to reflect current market costs of providing the service. This still remains a very competitive rate in a market where residents have substantial choice over the provider.
Alleygate Key Sale	Small increase proposed. The fee is calculated based upon the cost of the keys purchased by Swale Borough Council. This has recently been increased by the supplier by 30p. The fee could be increased to incorporate the cost and time taken for the maintenance and repairs to the alley gates across both schemes and the time. The current charge is only for the cost of the purchase of the replacement keys.
Room Hire of Swale House	The change to the commercial fees is that the figures have been rounded. There is to be a return to the principle that the non-commercial rate is 50% of the commercial rate and to reflect the fact that the Committee Room is larger than the Assembly Room and has recently been refurbished.
Legal Charges for Third Parties	Increase of 1% is proposed on the basis that the majority of the service expenditure is on salaries.
Houses in Multiple Occupation (HMOs)	Increase of 1% is proposed based on salary costs. Level of fees has previously been considered by Kent Housing Technical Group.
Home Inspection for Immigration Application Fee	Increase of 1% is proposed based on salary costs.

Fee or Charge	Comments
Bootcamp	Proposed new charge. This will allow Swale Borough Council to have greater control over individuals and organisations using our open spaces. Charges have been compared with five other councils across the country.
Traffic Regulation Order Applications	Swale Borough Council has been offering the service for a little while but without an approved fee attached to it. Our proposed fees are lower than Kent County Council to stimulate interest in our service and are comparable with other authorities. Most other authorities charge for this service.

recommended for 2016/17

Fee or Charge	Comments
Hire of Halls (King George's Pavilion)	A decrease to the charges is proposed based on the current facilities available within the hall.
Requests for Environmental Information (e.g. planning, contaminated land)	Changes are proposed in light of case law stating that fees can only be set to cover costs.
Planning Photocopying Charges	Changes are proposed in light of case law stating that fees can only be set to cover costs.

- 3.4 Below is a list of fees and charges set by the Government. Charges have been amended to reflect the current policy/advice:

 - Penalty charge notices for car parking/environmental response

4. Alternative Options

4.1 The alternative would be to propose a general flat rate increase or no increases in fees or charges. These alternatives would not be recommended as they may fail to take into account individual circumstance or the increased cost of delivering services.
