1 APOLOGIES FOR ABSENCE

There were no apologies for absence.

2 RECORD OF MEETING

The record of the meeting held on 23 September 2015 were agreed as a correct record and signed by the Chairman.

4 URGENT MATTERS BY REASON OF SPECIAL CIRCUMSTANCES

There were no urgent matters.

5 DEVELOPMENT OF CONSULTANCY AS A LOCAL AUTHORITY TRADING COMPANY

The Director of South Thames Gateway (STG) Building Control Partnership introduced the report which sought agreement from the Joint Committee for funding to develop a business case to deliver the consultancy through a Local Authority Trading Company.

The Director highlighted the main points in the report.

Members spoke in support of the proposal.

Resolved:

(1) That it be recommended that the respective partner authorities provide £2,000 each to secure the delivery of the Business Plan objective.

6 ANNUAL AUDIT AND INSPECTION LETTER

The Finance Business Partner introduced the report which presented the external auditor's certificate and opinion in respect of the Joint Committee's accounts for 2014/15.

The Finance Business Partner confirmed that no errors had been identified, and reported that it was no longer a requirement for joint committees to have their accounts audited. He asked Members if they wished to continue the audit services and confirmed, that in any case there would be a periodic review by internal audit.

Members were happy to dispense with the separate audit.

Resolved:

- (1) That the external auditor's certificate and opinion as presented be noted.
- (2) That the joint committee audit ends and an effective financial and governance framework is maintained for STG Building Control.

Resolved:

- (2) That the final contributions figures, which will be included in each authority's budget planning process for 2016/17 be noted.

Summary

This report sets out the proposed meetings schedule for the 2016/2017 municipal year.

1. Budget and Policy Framework

1.1 The Constitution for the South Thames Gateway Building Control Joint Committee specifies that the timetable shall be adopted at the Annual General Meeting.

2. Background

2.1 Gravesham, Medway and Swale Councils have all agreed to delegate their respective building control functions to the Joint Committee. This report presents the proposed dates for 2016/17 in advance of the Annual General Meeting.

3. Schedule of Meetings

- 3.1 The Constitution for the South Thames Gateway Building Control Joint Committee specifies that the schedule of meetings shall be agreed at the Annual General Meeting.
- 3.2 The Joint Committee is being asked to consider a programme of meetings for the 2016/17 municipal year in advance of a decision being made at the Annual General Meeting in June 2016, in order to provide some certainty for Members, and the Partner Authorities, on the schedule of meetings during 2016/17.

 - Thursday 9 June 2016 (AGM)
 - Thursday 22 September 2016
 - Thursday 8 December 2016
 - Thursday 16 March 2017.

4 Financial and Legal Implications

6. Legal Implications

- 6.1 The Joint Committee was established pursuant to powers under: -
 - Local Government Act 1972 sections 101, 102, 111, 112 and 113
 - Local Government Act 2000 sections 2, 19 and 20
 - Regulations made under these acts.
- 6.2 The arrangements for this joint committee have been designed to ensure compliance with the Local Authorities (Functions and Responsibilities) (England) Regulations 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000, which set out the functions that should be carried out by Council (or one of its committee) and functions that can be carried out by the Executive. Building control is a function of the Executive or Cabinet and can be discharged by the Joint Committee and those functions have been delegated by the Partners Authorities' Executives. By law, two elements of the service cannot be executive functions, namely staffing matters and enforcement activity by Building Control, and these have been delegated to the Joint Committee by the Partner Authorities' respective Full Councils.

7. Risk Management

7.1 There are no risk management implications arising from this report.

8. Recommendations

- 8.1 The Joint Committee is recommended to
 - a) Agree the timetable of meetings for the 2015/2016 municipal year (as set out in paragraph 3.3)
