#### **Kent County Council Community Services Consultation**

Kent County Council (KCC) has launched a public consultation on its Community Services which runs from 17 January to 26 March 2023.

The consultation proposes changes to the way we use our buildings to deliver some of our community services. We invite your feedback on our proposals as part of this consultation.

#### Why are we proposing changes?

The Council has experienced big increases in costs and has less money to spend. So we need to look ahead and do things differently to make sure we can still help residents in the years to come. Whilst ensuring effective support for residents who need our services, we need to:

- tackle the rising costs of maintaining our many buildings
- find savings, so we can balance the budget
- reduce our carbon footprint to meet our Net-Zero ambitions.

#### What services are included in the proposals?

Children's Centres and Youth Hubs, Public Health Services for Children and Families, Community Services for Adults with Learning Disabilities, Community Learning and Skills, and Gateways.

#### What are we proposing?

- Having fewer permanent buildings, meaning that some of our buildings would close we want to keep buildings in areas where they are needed the most
- Co-locating more of our services, meaning more than one service would be available from some of the buildings you might visit
- Continuing to deliver some services by outreach, which means they do not take place in a
  dedicated or permanent space, but move around to when and where they are needed
- Ensuring residents can continue to access services and information online.

Our proposals have been designed by considering where there is greatest need for our services.

5.	Refurbishment of King George V Toilet Refurbishment	Cllr Sarah Stephen brought a proposal to the September 2022 meeting to consider the refurbishment of the King George V toilet. The Western AC agreed to allocate £5,054 to this project. They requested that an alternative hardwearing wall covering as an alternative to white roc be used.  The Buildings Manager advised that the project is planned to take place during the winter months when King George Park would be less busy. The contractor has been asked to investigate an alternative wall covering instead of white roc, as per the Area Committee comments. Area Committee members considered a proposal to help homeowners in the Western area with reducing their energy costs. SBC provided a Fuel and Water Home Advisor Service, managed by the Swale charity Children and Families. One of the services provided by the Advisor was to give households advice on ways to reduce their use of energy and thereby reducing costs. As part of the service, energy efficient packs were given out which contained items like radiator reflectors, draft excluders, LED light bulbs and timers. The content of the packs were tailored to the needs of the household. Each pack costed approximately £50. The proposal was to allocate funds to the Fuel & Water Home Advisor Service via the charity Children and Families so the Advisor could provide energy efficient packs to households in the Western area. Appendix 1

#### Western Area Committee Youth Provision

Provision started at the beginning of November 2022, led by Adam McKinely, (Community safety warden and Vibe detached youth worker), with a team of Vibe youth workers.

The team have worked in pairs for 6 hours a week, spread over 2 or 3 evenings. They have trialled different times to target young people as they get home from school and as they are out in the evening with friends. They completed the first 6 weeks at Christmas and are currently in the middle of the second 6 week provision.

The team have taken the Vibe youth van to as many areas as possible including The Meads, Iwade, Newington, Upchurch, Hartlip, Borden, Lower Halstow, Bredgar, Tunstall, Rodmersham, Milstead, Bobbing and Bapchild.

We are continuing to visit all locations and have found places in the areas where young people gather such as youth shelters, village halls and local shops. Despite it being the winter months, and therefore not the best time of year to engage in detached work, we have been able to make connections with young people in Iwade, Newington, the Meads, and Borden, advertising on social media where our van will be. The team have set up youth meet ups for this term in Iwade, Newington and the Meads and will continue to add others. These meet ups will be focused on recording and reporting the opinions and feedback of young people in the area. We will look to get these reports to you by March. All other areas are visited once a week. The general feedback from young people so far is that they feel overlooked or isolated as they live in villages and are unable to attend youth provision in Sittingbourne. They want somewhere for older young people to hang out, and the provision of older youth clubs. Two of the team attended the Iwade Parish council meeting on request to represent the voice of the young person and youth provision in the village, and were able to provide this feedback.

We are aware that this provision does not need to be competed until May, so we are considering taking a break after half term, and then continuing with the final 6 weeks when the weather is warmer to increase the potential of engagement with young people.

Thank you to everyone who has continued to provide input into the development of these Walking & Cycling Trails.

All the ground-truthing work of the four walks has now been complete. During this process:

- lots of changes have been made to the original concept routes
- 12 fault reports have been submitted to Kent PROW
- The step-by-step guides have been created
- A theme has been created for each walk

One of the original walks – The Meads-Milton Trail has had to be dropped as so much of the walk was through residential streets, we could not find a way of making it attractive. Plus, a considerable amount of the walk was outside the Western Area. Consequently, a new walk through Upchurch and Lower Halstow has been developed linking in with the Saxon Shore Way and the England Coast Path.

- Birds Boats & Countryside


Tribal Voice Communications (TVC) work is now finished, although they will be reviewing the text and maps as we move through production.


#### Next stages:

- Print map leaflets and distribute



# Proposed reduction of bus services in the Swale Western Area Response from Kent County Council

Dear Cllr Corrie Woodford

Thank you for your letter dated 1 November 2022, regarding the withdrawal of subsidy for bus service 8 and, which to date has been subsidised by KCC. I am sorry that the need to reduce our bus subsidy has implications for you and will comment on the position below.

This Council has fought hard to protect its budget in this area whilst other authorities have reduced their support or stopped spending money on bus services altogether. However, as the pressure on our finances has increased, the Council has needed to make tough decisions in order to guarantee that statutory services for our most vulnerable residents can continue. The impact of this does unfortunately mean that, as a Council, we are having to consider savings measures across a whole range of services.

In the previous financial year, KCC continued to spend over £6m per year on supporting bus services which are not commercially viable to bus operators owing to the limited use that is made of them. It is understood that these services are valued by those that use them, but as the costs of providing them are increasing and their use has fallen since the pandemic, this has become an area where we can no longer sustain funding at current levels. Ultimately this is a discretionary area of spend and in order to meet our legal duty to set a balanced budget we have therefore had to reduce our financial commitment by £2.2m when setting the budget for the 2022/23 financial year.

To retain spend in this area and for the Council overall within the budget available we identified contracts for possible withdrawal using the Council's criteria for the prioritisation of services. These take account of the nature of the service, the availability of alternative services and value for money measured on a subsidy per journey basis. The approach we took and the services identified for potential withdrawal were then subject to an Equalities Impact Assessment informed and updated by a full public consultation that ran from February to April of this year.

Following consideration of the outcomes of the consultation and the updated Equalities Impact Assessments we decided to protect the funding for some services, notably the Kent Karrier Dial-a-Ride services. These services are used by some of our most vulnerable residents who through either age, disability or location are unable to use other public transport, and protecting these services meant that they can be accessed by existing users as well as those affected by other changes to bus services.

We will continue to spend £4m per year on supporting bus services, which is more than many other authorities, and we are also making funding available to support

Parish Councils and other Community groups if they want to find local solutions to transport needs in their area.

Unfortunately, whilst the Council would like to be able to protect all of the services it currently supports and indeed have additional monies that we could use to retain other buses being withdrawn by bus operators, this is simply impossible within the funding that we have available. Therefore, following extended consideration of the matter by our Environment and Transport Committee and then by Full Council, we have regrettably had to make the decision to withdraw the funding for 38 service contracts which we expect to stop operating from Sunday 12th February.

With regard to your particular comments about the provision of services carrying school children, whilst understanding the particular issues that this will create for some families, the provision of these services does, I'm afraid, fall into the same category as journeys made by other users. The need for the Council to arrange transport for school children is governed by national legislation which identifies which children are entitled to free transport to school, and if there are children with this entitlement using services being withdrawn then alternative arrangements will be made. Whilst the Council tries to support sustainable access to education through sustainable means, outside of those children with a legal entitlement this is also a discretionary activity and the Council simply cannot guarantee buses or other transport for all children in the County.

I note your comments about the use of other forms of funding in the form of money from the National Bus Strategy and other Covid support grants that have been provided by Government. Unfortunately at the time of writing the National Bus Strategy funding is yet to be secured and the rules around the use of this and Covid funding is clear that it should not be used to replace existing services except where short term support may enable services to continue on a without subsidy basis in the longer term, which would not be the case for services which have always relied upon ongoing levels of subsidy.

I am sorry that I can only explain why we have had to arrive at such a regrettable decision rather than provide hope of a different outcome.
