The Service Committee Chairs and their Vice-Chairs met on 11 July 2023 for a facilitated workshop, and on 3 August 2023 for a meeting with officers, to discuss their vision and ambition for the Borough and to consider what the priorities for the Council should be for the period 2023-2027.

Members agreed the following five proposed priorities and would like to hear Area Committees' comments before progressing further with work on the Corporate Plan:

Sittingbourne Tennis Club	A report concerning the proposed improvements to Milton Rec & King George's PF tennis courts was considered by the Area Committee at the December 2022 meeting and the Lawn Tennis Associations proposals were supported by Members. A report on the Tennis Court Improvement Project was taken to the Community Committee on 1 March 2023. The designated usage of courts from multi-use to tennis only at Milton Recreation Ground was agreed. It was also agreed that there would be a sinking fund commitment and ongoing maintenance responsibility as part of the bid for funding from the LTA and that the Council applied for improvement funding from the LTA.	Contracts have now been signed and works commenced on 10 August at both locations. Works are scheduled to last between 8 and 10 weeks. Signage has been installed and a new online bookings system at Milton is being designed. King George's already has online bookings available. The Tennis Club at Milton have been informed throughout the process. Works have progressed well in the first week with no issues of note.

7.	Swale Local Heritage List	Updates have been given at previous meetings on the Swale Local Heritage List.	The 6-week duration initially provided for invitation for nominations was extended by another 3 weeks and finally concluded on 17th July 2023. The officers are in the process of collating all the nominations received. There will be a Selection Panel set up in Autumn 2023 to assess those considered worthy of including on the Local Heritage List
8.	Swale Public Transport Group	Mr Jackie Davidson (resident) said before the Pandemic there used to be a Swale Public Transport Group led by SBC which looked at improving public transport in Swale. Mr Davidson asked if this group could be reinstated. Related to this the Chair confirmed that bus companies and representatives from KCC would be invited to the September 2023 Sittingbourne Area Committee meeting.	The Director of Regeneration & Neighbourhoods advised there were currently no plans to reinstate the Swale Public Transport Group. Before the pandemic there was a group that met called the Quality Bus Partnership (QBP). This was run by KCC. This stopped due to the government's new approach to bus infrastructure and their requirement that KCC establish what's called an Enhanced Partnership. This is run at a strategic level by KCC. It is responsible for delivering the county's Bus Service Improvement Plan. As such it will not cover any local district issues. To fill that gap, KCC are suggesting EP Local Focus Group (EP LFGs) meetings be set up in each district. They are happy to send representatives but cannot resource it like they used to do the QBP and so are asking districts to set up and resource them. These are not a statutory requirement.

			As such SBC are looking at if the local focus group should be set up and resourced. This is being discussed by members in September. If it is agreed to be set up it will be held every 6 months and be a forum for SBC, KCC and local bus operators to come together to discuss issues. Representatives of Stagecoach and Chalkwell
			have confirmed they will be attending the September 2023 meeting, a discussion will take place under item 5.

Update for Sittingbourne Area Committee – 5 September 2023

Periwinkle Water Mill Enhancement Project

In view of the sole tender quote which came in at the end of last year significantly over the anticipated budget, the Conservation & Design Team has been in the process of exploring an alternative procurement option given the need to keep the project within budget.

In liaison with project advisors East Kent Engineering Partnership and the Council's Health, Safety & Risk Officer, the team has concluded it is feasible to eliminate structural interventions to limit project costs by combination of site management and warning signage/info, in order to help ensure that the project can be delivered within budget. Officers were previously waiting for an estimate for the landscaping works from the Council's term landscape contractors for green spaces, having already received a favourable estimate from a separate contractor for the general building and metalwork fabrication/installation needed. However, the term landscape contractor has advised it is not in a position to be able to carry out the proposed landscaping works, so we now have an updated quote from the Council's term building contractor for the landscaping works (in addition to the building related work), which is reasonable, this being based on the landscaping works being carried out by a subcontractor.

Landscaping works being carried out by the Council's term building contractor (albeit in the form of it managing a specialist subcontractor) is outside the scope of the Council's contract arrangement with the company, so officers are in the process of applying for the waiver which would need to be agreed to allow officers to effectively work around this issue. If the waiver is agreed, as anticipated, it is expected that works should be able to commence in September or October 2023, with the landscaping works being the last element of work to be carried out, to coincide with the start of the autumn planting season.
