# 239 REVIEW OF A HACKNEY CARRIAGE LICENCE

The Licensing Officer introduced the report which sought to consider whether the Respondent was a 'fit and proper person' for the purposes of the Town Police Clauses Act 1847 and the Local Government (Miscellaneous Provisions) Act 1976 and whether the applicant should be granted a Dual Hackney Carriage/Private Hire driver's licence in line with Swale Borough Council (SBC) Taxi Policy.

The Licensing Officer advised Members that page 53 of the SBC Taxi Policy stated that if the taxi driver had been convicted of dishonesty the licence will not be granted until at least seven years had elapsed since the completion of any sentence imposed.

The Chair asked the Respondent to present their case and asked questions.

The Respondent gave a supporting statement to their case.

Members of the Sub-Committee adjourned at 2:14 pm to make their decision.
