<b>DETAILS OF ALTERNATIVE OPTIONS CONSIDERED AND REJECTED</b>	The alternative would be to wait until the land swap agreement has completed but this would result in an unnecessary delay to the phase 2 roadworks that are essential for the start of construction to the leisure buildings. This would delay the Cinema, Restaurants and Hotel and would prolong the development and extend the disruption to the town centre.
