| <p>SUMMARY OF OFFICER DECISION AND REASON FOR THAT DECISION</p> | <p>Decision made – Reduced the amount of grant which is to be repaid.</p> <p>The Council recently invested a considerable sum to adapt the applicants existing home and whilst the reasons for moving are understood they feel repayment of part of the grant will not be a contributing factor to any financial hardship given the circumstances around the way the property was financed and sold. The Council therefore feel the repayment conditions should be adhered to, but the amount to be paid will be reduced to reflect the time remaining on the existing terms and condition; the amount to be repaid is reduced from £10,000 to £7,000. The repaid grant will be used to fund future grants and to assist additional people with similar needs.</p> |
