This is a small scale operation with the aim to enhance the ambience of Queenborough Harbour not to detract from it. We will have a limited amount of seating which is currently 3 benches and we do not intend to have much more. We may play music probably no more than a couple of times a year as part of community days such as Queenborough Independence Day.
The site plan which accompanies this application details the licensable area to be used on a day to day basis with a yellow outline. The red outline for the whole of the harbour is to allow for any market trader on Queenborough Harbour Market day to trade under the auspices of this licence if we are happy for them to do so
It is not our intention to disturb nearby residents in any way and we will be happy to work with the local community should issues arise that they believe are to do with how this small hut will operate

    - a performance of unamplified live music between 08.00 and
       23.00 on any day, on any premises.
    - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
    - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
    - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
    - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

  - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
