### 1 Purpose of Report and Executive Summary

1.1. This report sets out the need to reprogramme the schedule of uplighting for Sheerness Clock Tower following the passing of Queen Elizabeth II and makes recommendations for any further changes.

## 2 Background

- 2.1. Sheerness Clock Tower was fully restored between 2021 and 2022, following the commitment of funds from Swale Borough Council's (SBC) High Streets Fund.
- 2.2. As part of these works, a coloured illumination schedule was introduced for the uplighters. Following internal SBC research and consideration, the schedule was set as per the attached Appendix I. Illumination takes place from half an hour before dusk through until midnight.
- 2.3. Reprogramming the uplighter schedule requires input from the installation contractor, either via on-site attendance, or via remote programming support (with an officer on-site to upload changes).
- 2.4. Given that this incurs costs, it was foreseen that the schedule would not be changed.
- 2.5. Following the passing of the Queen Elizabeth II, the illumination will, however, need to be reprogrammed to no longer mark her official birthday and instead to mark King Charles' birthday. This presents the opportunity to review whether other changes to the scheduling would be welcome.
- 2.6. This reprogramming will be funded by SBC.

### 3 Proposal

- 3.1. Sheppey Area Committee is invited to discuss and agree the updated static schedule of illumination of the Sheerness Clock Tower.
- 3.2. These changes will need to be agreed in good time to align with the removal of the scheduling of the late Queen's birthday illumination, and for the King's birthday illumination to be programmed i.e. latter part of May at the latest.
- 3.3. Sheppey Area Committee is invited to take on responsibility for agreeing and implementing any future discretionary changes to the illumination schedule (noting that this will come at a cost).

### 4 Alternative Options

- 4.1 The illumination could be switched off, either now or if any of the future uplighting schedule becomes obsolete. This is not recommended, as this is a welcome feature of the refurbished Clock Tower.
- 4.2 Reprogramming could potentially be undertaken independent of the installer's support. This is not recommended, as this is a technical exercise, with potential reputational ramifications if the schedule is not delivered correctly. There is no identified in-house expertise within SBC to undertake the work.
- 4.3 Agreement could be reached not to change the illumination schedule at any point other than when necessitated by external circumstance.

#### 5 Consultation Undertaken

- 5.1 The initial uplighting schedule was determined following internal SBC consideration, and review of the lighting schedule of comparator landmarks across the county.
- 5.2 These proposals have been considered by members of the administration.
