1 Purpose of Report and Executive Summary

1.1 This report provides details of the results of an informal consultation undertaken with residents of Attlee Way, Sittingbourne, on the proposed extension to the existing double yellow lines.

2 Background

2.1 Following a request from the Ward Member, via the County Member for the area, an informal consultation took place with residents on proposals to extend the existing double yellow lines on the north side of Attlee Way, Sittingbourne, from the junction of Satis Avenue to the junction of Foxgrove, including corner protection on the Foxgrove junction.

3 Proposals

- 3.1 The proposals, to be funded through the County Members' Grant, were requested to assist vehicle movements and improve sightlines for vehicles turning into Attlee Way by removing parked vehicles nearby.
- 3.2 A copy of the consultation material, which includes a plan of the proposals, can be found in Annex A, and the results of the consultation can be found in Annex B.

4 Alternative Options Considered

4.1 There were no alterative options considered at this stage.

5 Consultation Undertaken or Proposed

- 5.1 As stated above, an informal consultation took place with residents on the proposals, and a summary of the results of the consultation can be found in Annex B.
- 5.2 Of the 12 properties consulted, a total of 7 responses (58%) were received, with 6 (86%) supporting the proposed extension to the double yellow lines and 1 (14%) objecting on the grounds that the proposals would displace parked vehicles into adjoining roads.
- 5.3 In light of the majority support for the proposals, Members are asked to note the contents of this report and recommend that a Traffic Regulation Order is drafted based on the proposals. As part of the Traffic Order process, a formal consultation will be undertaken and any formal objections received will be reported back to the Swale Joint Transportation Board for further consideration.
