1 Purpose of Report and Executive Summary

1.1 The purpose of this report is to ask Full Council to agree that the Local Plan Review process be updated to a Regulation 18 draft Plan consultation commencing in quarter 4 of 2025 and a Regulation 19 pre-submission plan consultation commencing in quarter 2 of 2026, and subsequently to recommend the accompanying Local Development Scheme that formally sets out the timetable. The report taken to Policy and Resources committee on 27th November 2024 is provided at Appendix I, and a tabled update that informed the discussion is set out at Appendix II.

2 Background

2.1 The discussion at Policy and Resources committee involved the proposed timing of the Regulation 18 draft Plan consultation and the impact of the two planning applications commonly known as Highsted that had been called in by the Secretary of State as set out in the tabled updated paper provided at Appendix II.

2.2 Policy and Resources committee resolved hat the amended revised timetable for Regulation 18 draft Plan consultation in quarter 4 of 2025 and a Regulation 19 presubmission plan consultation in quarter 2 of 2026 be agreed by Full Counciland that the Local Development Scheme shown at Appendix I of the report be be agreed by Full Council.
