# **1** Purpose of Report and Executive Summary

1.1 This report sets out the recommendations from General Purposes Committee (GPC) held on 2 March 2016 for consideration and adoption by Council.

- Suggested changes to the Officer Scheme of Delegation.

- Suggested changes to the voting procedures contained within 4.1 Council procedure Notes
