## Response:

Regeneration is one of the Council's top priorities. Regenerating our Borough is the most effective way of alleviating deep lying social issues that affect some of our communities – for example around skills attainment, income and deprivation, and health outcomes.

And as the government shifts the council funding regime to being based on the income received from business rates, driving local economic growth will also be key to our ability in the long term to fund and deliver excellent services for all our community.

We have also been highly successful in driving regeneration in recent years – for example, and as set out in the 2015/16 Finance Outturn report that recently came to Cabinet, we were one of eleven Kent authorities in a business rate pool in that year, and Swale generated the greatest increase in business rates of all authorities within that pool – a testament to the hard work of our Directors of Regeneration and the rest of the Regeneration Team over recent years, and the coming to fruition of a number of key projects.

But we have further significant projects that we are working hard to deliver – whether in Sittingbourne, on the Island, in Faversham, and as part of our wider roads and transport network. This requires the Planning, Housing, and Economy and Communities Divisions to work closely together, under a leader who can drive change and work in partnership to deliver our vision of a Borough to be Proud of.
